Opening Statement

Few years ago a Task Force El Nido Challenge was created and mobilized to propel environmental rehabilitation activities in the initial four (4) barangays of El Nido, Palawan along with Information, Education, and Communication (IEC) campaigns. In coordination with the various government units, these activities consisted of water quality and solid waste management monitoring, demarcation/delineation of and inventory of illegal structures in easement zones as well as in the immediate forest lands, issuing corresponding notices/orders, and progressive monitoring of compliance thereafter. Later in the re-entry plan of the Officer- In-Charge of the concerned Community Environment and Natural Resources Office, this initiative of recovering the legal easement was also carried out in Barangay Bucana, El Nido, Palawan.

Team leaders may sign simple correspondences routinely in nature of their herein tasks furnishing a copy each to the CENRO and Protected Area Management Office of El Nido-Taytay Managed Resource Protected Area.
