- c. The subject lot was plotted and evaluated based on the attached certification by the Office of the CENRO.



I am submitting this report in compliance with your instruction to conduct an investigation over a parcel of land occupied by Buenavista Elementary School, Barangay Buenvista, Puerto Princesa City.

#### SUBJECT LOT

The subject of this investigation is a parcel of land occupied by Buenavista Elementary School located in Barangay Buenavista, Puerto Princesa City;

## **CLAIMANT**

Per record of this Office the said lot has no lot number and not yet surveyed.

#### PROCEEDINGS/ACTIVITIES UNDERTAKEN

Please be informed that on October 26, 2021 the undersigned together with the Chief, RPS Mildred A. Pascual, Special Investigator Christyl Pops B. Maningas and Math Aide Reynaldo V. Macola were assisted by Principal Jessie B. dela Cruz and conducted an ocular inspection/ground verification pertaining to the school site of Buenavista Elementary School located in Bgy. Buenavista, Puerto Princesa City.

The Team from this Office has undertaken the following:

- 1. Ocular inspection in the area to determine the actual occupation of the school
- 2. Conducted geotagging with proper coordination with the Dep-Ed Officials.

#### FINDINGS RECOMMENDATIONS

After the conduct of the investigation, we found out the following:

- 1. That the aforementioned lot is actually occupied and used by Buenavista Elementary School where the school buildings and other facilities are located and secured by semi-concrete fence.
- 2. That the aforementioned lot has no lot number and this Office has no record of application/request for Special Patent.
- 3. The subject per GPS reading the aforementioned parcel of land falls within portion of **AGRICULTURAL LAND (ALIENABLE AND DISPOSABLE AREA)** and within portion of **FORESTLAND/TIMBERLAND** per approved Land Classification Map 2598 Project No. 1-T, Block III certified on July 28, 1967.
- 4. Other findings:
  - 4.1 That the aforementioned lot is more or less **2,000 square meters** applying the 40 meter easement (adjacent to mangrove swamp) using the metered measuring devise however the exact area should be determined upon conduct of actual precise survey.
  - 4.2 That the said school site is covered by Tax Declaration No. 007-584 in the name of Department of Education Culture and Sports.
