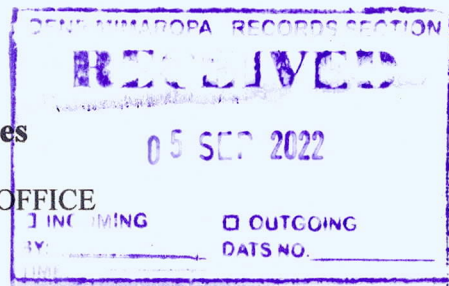

Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated August 05, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO Quick Response Team on September 20, 2021 at around 10:48 P.M. while conducting surveillance in response to the received information regarding the illegal transport of undocumented forest products at Sitio Awit, Barangay Abaroan, Roxas, Palawan. The team apprehended the Topdown Tricycle (EURO 150cc, color red) loaded with ten (10) pieces lumbers of Ipil species with total volume of 200 board feet and have estimated fair market value of Php90,000.00 and Php20,000.00 respectively.

The alleged driver of the Topdown Tricycle who managed to escape after colliding to the motorcycle of one of the apprehending officers is a certain Mr. Kutu Requina, a resident of Barangay Abaroan, Roxas, Palawan. CENRO Roxas secured a certification of sale dated February 03, 2022 from Daan Hari Motors Coprs stating that the subject motorcycle was sold to Mr. Danilo Nessia Requina of Barangay Abaroan.

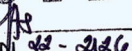
The apprehended lumbers and the vehicle are now deposited at CENRO Compound, Barangay III, Roxas, Palawan for safekeeping purposes under the custody of Foretser I Marces C. Lasangen.

Pursuant to Section 7, Item No. 1 of DAO 1997-32, notice dated February 16, 2022 was sent to Mr. Danilo Nessia Requina and the administrative hearing was conducted on February 16, 2022.

We concur with CENRO recommendation for the issuance of confiscation order for the lumbers and the conveyance.

Submitted is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

**I. FACTS OF THE CASE**

The apprehension was made by the DENR CENRO – Quick Response Team on September 20, 2021 at around 10:48 P.M. while conducting surveillance in response to the received information regarding an illegal transport of undocumented forest products. The driver of the topdown tricycle was able to immediately escape after colliding his topdown with the motorcycle of the apprehending officers thus resulting to a motorcycle accident. Based on the report, the alleged owner of the said topdown is a certain Kuti Requina, a resident of Barangay Abaroan, Roxas, Palawan. The subject forest products and conveyance were hauled to this Office compound for safekeeping under the custody of Forester I Marces C. Lasangen.

Upon investigation, this Office has secured a Certification of Sale dated February 3, 2022 from Daan Hari Motors Corps. stating that the a Euromotor DH150 with Engine No. 161FMJF2212538 was sold to Mr. Danilo Nessia Requina of Barangay Abaroan, Roxas, Palawan.



## **II. NOTICE OF HEARING**

Pursuant to the provisions of the Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 07, Item No. 01, issuance of Notice of Hearing for the conduct of administrative proceedings. Further, Notice of Hearing was issued to Mr. Danilo N. Requina and was scheduled on February 16, 2022

## **III. EVALUATION**

The administrative hearing was attended by Mr. Danilo Requina. During the said hearing, Mr. Requina admitted that he is the owner of the apprehended topdown however he denied his involvement in transporting the loaded undocumented lumbers. He stated that on the night of September 20, 2021, he went to sleep early, as usual, due to his old age (66). His topdown tricycle was parked along the road in front of his house and didn't know that someone took it until the morning of September 21, 2021 when he noticed that it was already gone. Then, a Barangay Tanod of Barangay Abaroan which is also his neighbor called and informed him that his topdown is at the Barangay Hall since it was apprehended due to loading of undocumented lumbers. Upon knowing the situation, he did not claim the said topdown in the fear that he would take the responsibility for the illegal activity since he was already old. Mr. Requina also stated that he does not know any 'Kuti' Requina and his children are namely Darry, Leo, Nerisa and Glenn, all have families of their own.

Upon evaluation of the Mr. Requina, the undersigned finds it impossible for the latter to run fast enough to escape from the apprehending officers especially during the night due to his old age and difficulty in walking.

## **IV. RECOMMENDATION**

In view hereof, the topdown tricycle with Engine No. 161FMJF2212538 loaded with ten (10) pieces Ipil lumber with equivalent volume of 200.00 board feet be forfeited in favor of the government that this Office will conduct further in depth investigation of the case to identify the driver of the apprehended tricycle at the time of the commission of the offense.

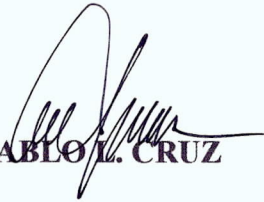

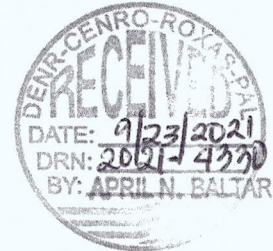

**SUBJECT** : **REPORT ON THE APPREHENDED IPIL LUMBERS RELATIVE TO THE REPORTED ILLEGAL ACTIVITY AT SITIO AWIT, BARANGAY ABAROAN, ROXAS, PALAWAN**



Please be informed that on September 20, 2021 around seven (7) o'clock in the evening the Quick Response Team (QRT) received information regarding the alleged hauling of undocumented lumber in Sitio Matalangao, Barangay Abaroan, Roxas, Palawan.

The immediately prepared to conduct surveillance to verify the veracity of the information. Around eight O'clock in the evening, the QRT together with Forest Protection Support Officer Donne G. Sabroso, Barangay Kagawad Roberto Estoya and two (2) Barangay Tanod started to monitor the place where the above-mentioned alleged illegally-sourced lumber may possibly be unloaded. After the monitoring at around nine O'clock, the team agreed to standby at the side of the road where the said alleged topdown vehicle passes-by going to Sitio Awit, which is purportedly the location of unloading. Then, at around ten O'clock, the team heard a whizzing sound of motorcycle and immediately the alerted and went to the road and check. About a minute or two, we saw one (1) unit topdown tricycle approaching loaded with lumber. The team flagged down the driver to stop the conveyance but deliberately ignored and drove fast to evade from us. After that, the team decide to follow him to properly apprehend but the driver of the topdown tricycle collide our two team members in tandem, Forest Ranger Christopher T. Padrones and Forest Ranger Charlie Rabang resulting to the motorcycle accident. Furthermore, the driver and his helper left the vehicle loaded with Ipil lumber and runaway fast and totally escaped. The team scaled and apprehend ten (10) pcs 2x5x24 Ipil lumber with aggregate volume of two hundred (200) board feet and one (1) unit of topdown tricycle powered by EURO 150 cc. motorcycle with engine no. 161FMJ, F2212538, accordingly, owned by a.k.a. Kuti Requina, a resident of Barangay Abaroan, Roxas, Palawan, and the team posted Notice of Apprehension on the site where the lumber loaded on a conveyance had been apprehended and proceeded to the barangay hall to file barangay blotter and for temporary custody of the above apprehended Ipil lumber and conveyance before hauling to the CENRO Compound for safekeeping and proper disposition.

Attached herewith are the geo-tagged photos, Notice of Apprehension, Apprehension Receipt and barangay blotter report.

The undersigned team will continue to investigate regarding this matter to build-up evidences. And, it is also being recommended to request a Certificate of Ownership of Mr. Requina from EURO Company for evidence purposes.

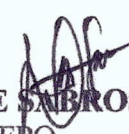

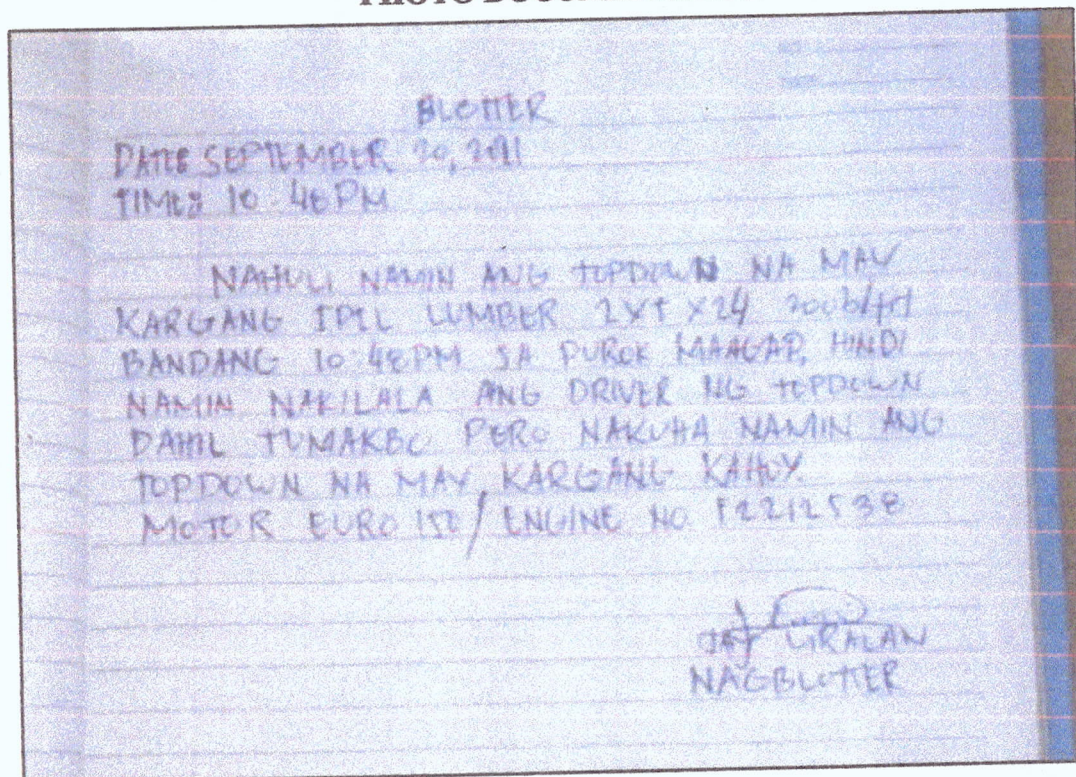
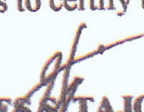


Photo 1 Showing the Barangay Blotter Report of the apprehension

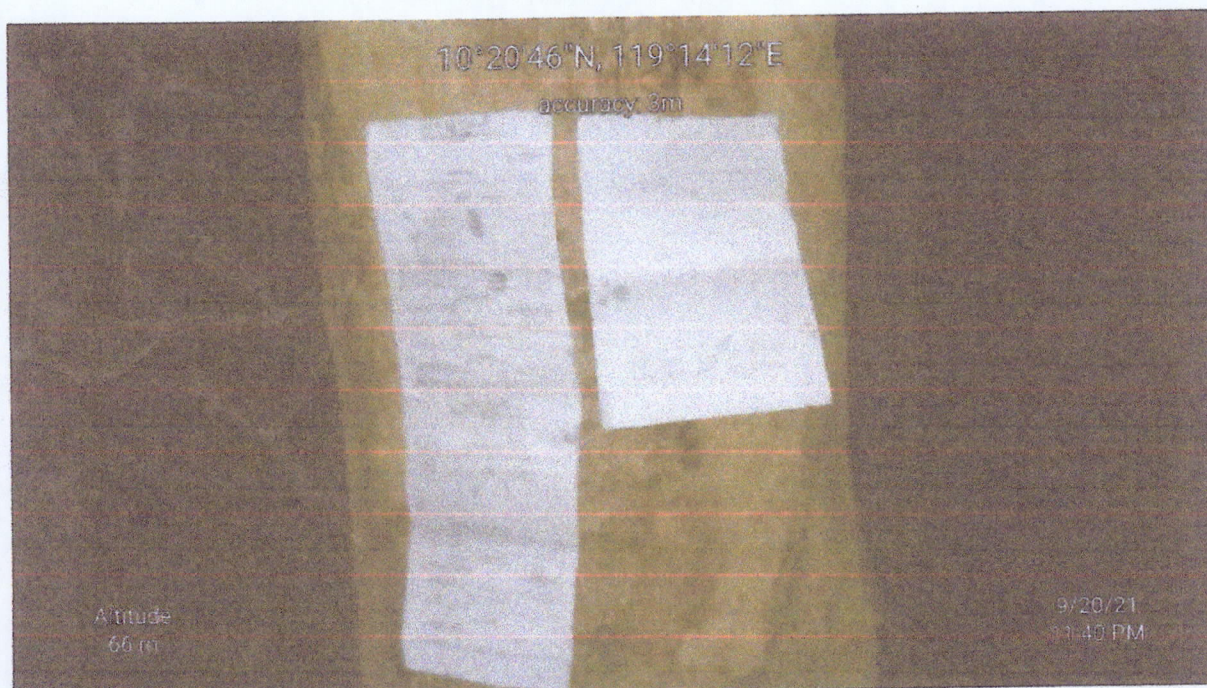
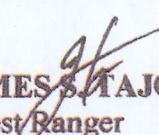


Photo 4 Showing posted Notice of Apprehension and Apprehension Receipt
