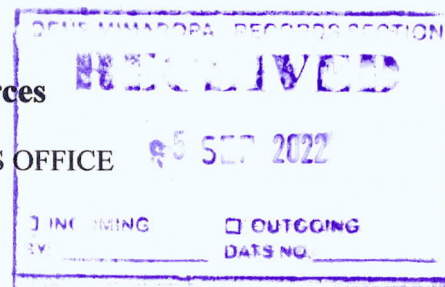


Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated August 16, 2022 relative the above subject.

Per memorandum, the apprehension was made on June 24, 2022 at around 9:00 P.M. by the Monitoring and Enforcement Section of CENRO Quezon together with Naval Forces West Personnel in Sitio Ranao, Barangay Maasin, Quezon, Palawan. The team conducting monitoring and patrolling activities and apprehended the abandoned lumbers that left unattended at the vacant lot area of the said barangay and no one claims for its ownership. The apprehended lumbers were twenty-seven (27) pieces (169 board feet) of Putian and Amugis species with estimated fair market value of lumber is Php6,760.00.

The subject lumbers were brought to DENR CENRO Quezon Compound, Quezon, Palawan under the custody of FT II Armando J. Batayo for safekeeping purposes.

Notices to the public dated June 30, 2022, July 15, 2022 and July 29, 2022 were posted on three (3) different conspicuous places in the municipality of Quezon, Palawan in relation to Section 8, Item No. 3 of DAO 1997-32. However, no one appeared and claimed in the Office. Hence, the absence of the owner/claimants to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

Therefore, we concur with the CENRO recommendation for the issuance of confiscation order and order of finality of the forest product in favor of the government.



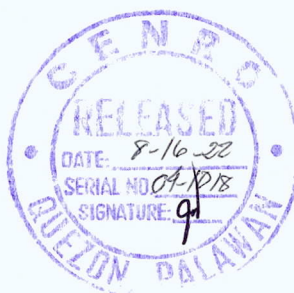

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32.

**I. FACTS OF CASE**

**WHAT** : Apprehension of Twenty-Seven (27) pieces of Putian and Amugis lumbers having a total volume of 169 board feet with an estimated fair market value of Php 6,760.00.

**WHEN** : At around 9:00 PM of June 24, 2022

**WHO** : No claimant/Abandoned

**WHERE** : Sitio Ranao, Brgy Maasin, Quezon, Palawan

**HOW** : On or about 8:15 PM of June 24, 2022, the CENRO Quezon, Monitoring and Enforcement Section team received an information from a reliable source that there was an ongoing hauling of undocumented lumbers in the said area. Together with Naval Forces West (NAVFORWEST) personnel, the team immediately proceeded to the said area for verification. Upon arrival at the specific location, fresh cut lumbers were discovered and had apprehended Twenty-Seven (27) pieces of Putian and Amugis lumbers having a total volume of 169 board feet. Per on-site investigation, no person/claimant found in the area, hence, declared abandoned. The apprehended lumbers were brought to DENR-CENRO Quezon, compound Quezon, Palawan for safekeeping under the custody of FT. II Armando J. Batayo. Subsequently, a Seizure Receipt and Seizure Order dated July 1, 2022 were issued by the undersigned.

**II. NOTICE TO THE PUBLIC FOR THE CONDUCT OF HEARING:**

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks at the different conspicuous place of Quezon, Palawan was conducted by this Office.

**III. FINDINGS/EVALUATION:**

In spite of the three (3) consecutive notices posted however, no claimant appeared before this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.


**IV. APPLICABLE LAWS:**

Department Administrative Order No. 97-32 Section 8, item no. 3, Notice of Hearing shall be posted at least three (3) times, once every week for three (3) consecutive weeks, in at least three (3) public places, including, but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

**V. RECOMMENDATION**

In view hereof, it is recommended that the Twenty-Seven (27) pieces of Putian and Amugis lumbers having total volume of 169 board feet with an estimated market value of Php 6,760.00 apprehended at Sitio Ranao, Brgy. Maasin, Quezon, Palawan be confiscated in favor of the government.

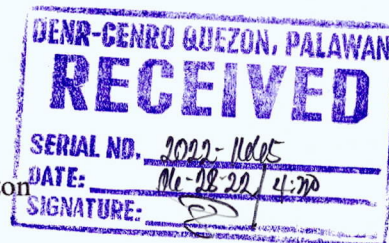

We conducted investigation at the nearby houses but we failed to gather any information of the identification of the said culprits.

The said forest products were apprehended in violation of Section 77 of PD 705 as amended and impounded at DENR CENRO Quezon compound for safekeeping.
