JOINT CHECKPOINT WITH THE PNP

Respectfully forwarded are the memoranda of CENRO Puerto Princesa, Palawan dated June 21, 2022 and July 12, 2022 relative the above subject.

Per memoranda, the apprehension was made on December 15, 2021 around 9:42 P.M. in the established joint DENR and PNP checkpoint at Barangay Sta. Lourdes, Puerto Princesa City, Palawan. The team flagged down the Isuzu Forward Truck with Plate No. CAM 8405 and visually searched the cargo and saw the furniture, door jamb and panel door made of Ipil species. The team apprehended the vehicle and its load for transporting furniture finished products without pertinent legal documents in violation of Section 77 of PD 705, as amended. The apprehended items were brought to CENRO Puerto Princesa for safekeeping under the custody of Forest Ranger Neil James Verzosa.

The owner of apprehended vehicle is Ms. Genna D. Adajar and has an estimated fair market value of Php1,500,000.00 while the furniture products have fair market value of Php40,000.00. Further, the PENRO Appraisal Team recommended for the temporary release of the subject conveyance thru memorandum dated August 10, 2022 with the bond of Php388,222.10 pursuant to DAO 1997-32.

Notices of hearings were sent to both parties and the hearings were conducted on January 19, 2021, February 7, 2022 and April 27, 2022 in relation to Section 8, Item No. 3 of DAO 1997-32.

During the first hearing, the driver Mr. Dan A. Rabang said that the owner of furniture is a certain Ms. Aileen Malanao who told him to deliver the said furniture to her house in Puerto Princesa City with Php2,000.00 charged for its transport.

We concur with CENRO recommendation for the temporary release of the conveyance subject to the provisions of DENR Administrative Order 1997-32 and to file appropriate charges against Mr. Dan Rabang (Driver) and Ms. Aileen Malanao (Furniture Owner) before the City Prosecutor's Office.

Unmindful that the items are made of prohibited species, and as Ailyn explained that it is her personal belongings and that they are not of commercial quantity nor it would be sold to another person, the driver transported the said items.

That, after the typhoon Odette, most of our livestock and coconut trees were destroyed, the truck subject of this case is now the only source of income our family can depend on.

My husband has been bedridden for couple of years due to severe illness, I am also sickly and cannot go for work anymore. I have two (2) children, the

other one is still in high school and the other one was forced to stop due to extreme financial condition.

WHEREFORE PREMISES COSIDERED, it is most respectfully prayed unto this Honorable Office that the said vehicle be temporarily released to me pending the resolution of the Honorable Office of the case.

Should a bond be required to have it temporarily released, it is further prayed for that the bond be reduced to the amount we can afford considering our current financial condition.

It will be of great help if the said vehicle will be released to us. We can use it to make a living to support our family's needs. It is our only hope so we can also send our sons to school again to continue their studies. It will also help us to have additional income so we can buy the medical needs which we badly needed at this point.

Should this Honorable Office grant this humble request, I undertake to surrender or to bring the said vehicle before this Honorable Office or to any government agency or before the Court, anytime, upon order.






Forwarding herewith are the rectified documents of the above-cited case which was returned in your memorandum dated June 14, 2022.

Respectfully submitted is the summary of Administrative Adjudication of Izusu Forward Truck with Plate No. CAM 405 loaded with sala set, door jamb, and panel door made of ipil.


#### I. FACTS OF THE CASE

On December 15, 2021, a joint DENR and PNP checkpoint was established at Brgy. Sta. Lourdes, Puerto Princesa City. At around 9:30 in the evening, an Izusu truck was spotted approaching the checkpoint, and one of the PNP personnel flagged down the said vehicle. The police officer politely asked if they can conduct a visual search, and the driver agreed to it opening the door of the truck. Upon looking at the cargoes, they saw the furniture, door jamb, and panel door. The driver was asked if he was carrying legal documents to transport said forest products, and he answered the negative. Immediately the personnel declared that they will be confiscating the vehicle including the furniture, door jamb, and panel door for violation of Sec. 77 of PD 705.

The vehicle was brought to the CENR Office while the copra was released to its lawful owner. During the first hearing, the driver Mr. Dan Rabang said that the owner of the furniture was his friend Ms. Aileen Malanao, who told him to deliver the said furniture to her house in Puerto Princesa City. He was given two thousand pesos (P 2,000.00) as payment for its transport. It was loaded in Sitio Little Caramay, Roxas, Palawan which according to him he did not inform the owner that he will transport the said furniture.

According to the testimony of the owner of the truck Ms. Genna Adajar, Mr. Dan Rabang has been the driver of their truck for about 4 years already and she trusted him when it comes to the discretion in loading cargoes. She did not expect that Mr. Rabang will load furniture since it has been her instruction not to load any illegal cargoes.

Mr. Rabang was amenable that it was his mistake since he did not ask permission to load the said furniture.

#### **III.EVALUATION**

Based on the facts of the case and the submitted documents, it appeared that the driver erred in transporting ipil furniture without proper documents. It also appeared that the owner of the truck Ms. Genna Adajar has no knowledge about the transaction of her driver Mr. Dan Rabang. Based on DAO 97-32 Section 9. Temporary Release of Conveyance pending final disposition of the case is allowed provided that the requirements are satisfied.

#### IV. RECOMMENDATION

The undersigned recommends that the forest products be forfeited in favor of the government and the truck be temporarily released to the owner for she was not among those who were apprehended and did not give consent to haul the undocumented forest products.

While, Mr. Dan Rabang (driver) and Ms. Aileen Malanao (furniture owner) have been found to conspire with each other to transport said forest products, hence, a criminal complaint be filed against them for violation of Section 77 of PD 705 as revised.

DOOR AND DRIVEN BY MR. DAN RABANG

 WHAT: Apprehension of 2 pcs convertible chair bed, 1 pc door jamb and 1 panel door all made of Ipil species without necessary permit hence a violation of sec. 77 of PD 705

2. WHO: Dan Rabang, resident of Bgy. Magara, Roxas, Palawan

3. WHEN: December 15, 2021 more or less 9:42 PM

4. WHERE: Sta. Lourdes, DENR Forest Products Monitoring Station

5. HOW: On the above-mentioned date and time, the MES personnel headed by OIC DMO/Chief MES/FIII Rodney G. Verian together with PNP personnel headed by their Team Leader PSSG Andy Barairo and Team Leader PSSG Dean Delos Reyes conducted a checkpoint on the National highway located at Bgy. Sta. Lourdes in front of DENR Forest Products Monitoring Station of Sta. Lourdes. During the said checkpoint all vehicles where visually search and drivers and passengers were reminded and informed of the prohibited transportation of forest product without permit or necessary documents.

Around 9:30 PM an Isuzu Truck was spotted approaching the checkpoint, one of the PNP elements flagged down the said vehicle which slowed down upon noticing our hand motion to him to stop the vehicle which he parked at the side of the road. We approached the vehicle and introduced ourselves as PNP and DENR personnel and the reason of our presence in the area. We asked for the name of the driver and he identified himself as Dan Rabang and showed to us his driver's license. Thereafter, we asked for his cargoes which he replied that it was "COPRA", we then politely asked if we can conduct a visual search of his driven vehicle, which he assented to. He voluntarily opened the closed van

by himself (the driver) and then and there, upon opening of the rear door of the closed van, we saw that aside from COPRA he has also carrying furnitures, door jamb and panel door with his vehicle. We asked the driver if he has permit for such forest products but he replied in negative. We then declared to him that we will be confiscating his driven vehicle and the 1 pc door jamb, 2 pcs convertible chair bed and 1 pc door panel for violation of Sec 77 of PD 705.

The vehicle with its forest products load is currently deposited at CENR Office, while the COPRAs were release to its lawful owner. Acknowledgement receipt was executed by the said owner for the release of his COPRAs which totaled 110 sacks upon inventory.







CHECKPOINT WITH THE PNP.

Respectfully submitted is the summary of Administrative Adjudication of Izusu Forward Truck with Plate No. CAM 405 loaded with sala set, door jamb, and panel door made of ipil.

## I. FACTS OF THE CASE

On December 15, 2021, a joint DENR and PNP checkpoint was established at Brgy. Sta. Lourdes, Puerto Princesa City. During the said checkpoint, all vehicles were visually searched and the drivers and passengers were reminded and informed of the prohibition of transporting forest products without permits or necessary documents.

At around 9:30 in the evening, an Izusu truck was spotted approaching the checkpoint, and one of the PNP personnel flagged down the said vehicle. The vehicle immediately slowed down and parked at the side of the road. The checkpoint personnel identified themselves and politely asked what the content of the truck is. The driver who identified himself as Mr. Dan Rabang said that his cargoes were copra. The police officer politely asked if they can conduct a visual search, and the driver agreed to it opening the door of the truck. Upon looking at the cargoes, they saw the furniture, door jamb, and panel door. The driver was asked if he was carrying legal documents to transport said forest products, and he answered the negative. Immediately the personnel declared that they will be confiscating the vehicle including the furniture, door jamb, and panel door for violation of Sec. 77 of PD 705.

The vehicle was brought to the CENR Office while the copra was released to its lawful owner. During the first hearing, the driver Mr. Dan Rabang said that the owner of the furniture was his friend Ms. Aileen Malanao, who told him to deliver the said furniture to her house in Puerto Princesa City. He was given two thousand pesos (P 2,000.00) as payment for its transport. According to him, Ms. Malanao said that it's okay to transport the said furniture since it is not for sale but for personal use which is also coming from their house in Roxas. It was loaded in Sitio Little Caramay, Roxas, Palawan which according to him he did not inform the owner that he will transport the said furniture.

According to the testimony of the owner of the truck Ms. Genna Adajar, Mr. Dan Rabang has been the driver of their truck for about 4 years already and she trusted him when it comes to the discretion in loading cargoes. However, they sometimes have communication difficulties due to lack of signal in their house. She did not expect that mr. rabangwill load furniture since it has been her instruction not to load any illegal cargoes.

Mr. Rabang was amenable that it was his mistake since he did not ask permission to load the said furniture.

### **III.EVALUATION**

Based on the facts of the case and the submitted documents, it appeared that the driver erred in transporting ipil furniture without proper documents. It also appeared that the owner of the truck Ms. Genna Adajar has no knowledge about the transaction of her driver Mr. Dan Rabang. Based on DAO 97-32 Section 9. Temporary Release of Conveyance pending final disposition of the case is allowed provided that the requirements are satisfied.

### IV. RECOMMENDATION

The undersigned recommends that the forest products be forfeited in favor of the government and the truck be temporarily released to the owner for she was not among those who were apprehended and did not give consent to haul the undocumented forest products.

While, Mr. Dan Rabang (driver) and Ms. Aileen Malanao (furniture owner) have been found to conspire with each other to transport said forest products, hence, a criminal complaint be filed against them for violation of Section 77 of PD 705 as revised.




