Respectfully forwarding the Memorandum dated August 4, 2022 issued by OIC-CENRO Pedro A. Velasco regarding the above-subject with enclosures.

On August 9, 2022, our Office received a copy of your Memorandum dated July 11, 2022 recommending for the issuance and renewal of the Tapping, Extraction, Collection Permit (TECP) of the Samahan ng mga Katutubong Batak sa Manggapin ng Bgy. Langogan (SKBML) subject to payment of performance bond in the amount of P 1,800,000.00 pursuant to the provisions of DENR Administrative Order (DAO) 2004-16 "Prescribing the Revised Schedule of Forestry Administrative Fee".

Prior to the receipt of our Office of the said memorandum, the CENRO Puerto Princesa City received a letter dated July 29, 2022 from SKBML on even date, copy of letter are hereto attached which was forwarded to our Office on August 8, 2022. In the said letter, the SKBML is appealing to your Office for the exemption from payment of performance bond amounting to One Million Eight Hundred Thousand Pesos (P1, 800, 000.00) due to the following reasons:

- The members of SKBML have no financial means to pay for the total amount of the performance bond considering that they were greatly affected by the pandemic during the past years and considering also that their barangay was one of the mostly affected barangays in Puerto Princesa City during the hit of typhoon Odette last December 17, 2021.
- 2. The members of SKBML have not yet fully recovered from the pandemic and hit of typhoon Odette which made it more difficult for them to sustain their everyday lives.
- 3. The subject land where SKBML harvest (tap, extract and collect) forest products such as almasiga, yantok, pulot-pukyutan and other forest products is within their ancestral land claim.

The SKBML further stated in their letter that they previously paid for a performance bond during their first application in the amount of P 1,200.00 duly substantiated with Official Receipt No. 3465461 dated October 1, 2018. If the amount for the payment of the performance bond would still be the same for their renewal, they can come up for the said amount. However, if it is still in the amount of P1, 800,000.00they could not afford to pay, even to borrow from other people, as none would ever lend them that high.

In line with this, this Office recommends for leniency and humanitarian consideration in favor of the SKBML to grant the renewal of their TECP exempting them from payment, if not, lessening the amount of performance bond in accordance with their ability to pay, on the basis of their right under the IPRA Law, or it they can post for a Twenty Five25% cash bond deposit in the form of surety bond to be paid within Five (5) year. This Office is likewise seeking from your Office other alternative options where we can help and support the said IPs/ICCs for the renewal of their TEPC.

We understand the situation of the IPs/ICCs in Barangay Langogan, Puerto Princesa City because we have witnessed their struggle during the typhoon Odette when all their forest products and means of livelihood where greatly damaged by the said typhoon.


