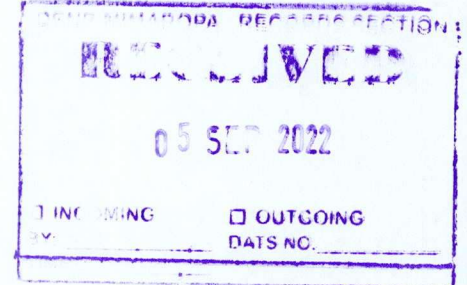

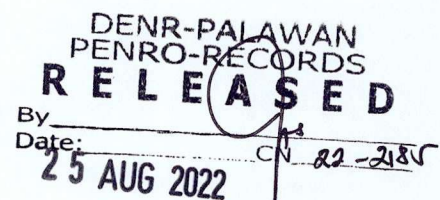



This pertains to the Resolutions and Minutes of Meeting of ENTMRPA Protected Area Management Board (PAMB) En Banc held on November 10, 2020 at Jurias Garden Hotel, El Nido, Palawan.

After review, the Minutes of the Meeting and seven (8) Resolutions passed by the Management Board are hereby APPROVED. The remaining four (4) of the eleven (11) resolutions are subject for clarification/rectification and resubmission.

We are providing certain comments on the four (4) Resolutions as well as on certain issues and concerns raised during the meeting as follows:



1) Request of Hon. Zumarraga for the 25% share from the IPAF of ENTMRPA for the development projects of their Barangay.	<ul style="list-style-type: none">- We would like to reiterate our previous comments on the same issue raised during the August 27, 2020 PAMB En Banc that BLGUs covered by the PA are not authorized to disburse PA-RIA fund neither the PAMO/PAMB authorized to download fund to BLGUs. Section 16 (IPAF) of RA 7586 as amended by RA 11038 and DAO 2019-05 provides that "income generated from the operation and management of the PA shall accrue to the IPAF and disbursements of PA-RIA (75%) shall be used solely for the protection, maintenance, administration and management of the PA and the implementation of duly approved projects of the PAMB."- We concur with the comment of the PAMO that BLGUs concerned are allowed to submit their respective project proposal/s subject for approval by the PAMB and must be aligned with the attainment of the objectives of the PAMP.
2) Resolution No. 029, Series of 2020 "A Resolution Earnestly Requesting the DENR Regional Executive Director to Lift the	<ul style="list-style-type: none">- The Regional Executive Director cannot approve the Resolution since lifting of the moratorium should be done by the DENR Secretary.

<p>2) Resolution No. 2020-016 "A Resolution for an extension of temporary closure of Small, Big Lagoon and Shimizu Island for recreational ecotourism-related activities"</p>	<p>Since it was agreed by the majority of the Management Board to revoke this Resolution, the PAMO should ensure that the protection and sustainable management of the Small & Big Lagoons and Shimizu Islands should not be compromised over economic-related purposes. It is reiterated that the PAMO should intensify their PA protection activities like: i) propose policy on this concerns and recommend to the PAMB as such being one of the functions and duties of the PAMO (Section 11-B d of RA 7586 as amended); and ii) install additional signages/billboards in strategic spots of the PA for tourists, tour guides and operators, and local communities to be reminded of the DOs and DON'Ts when they are in the PA. For sustainable management of the PA both for ecotourism and economic purposes, the PAMO/PAMB to seriously consider the recommendations of the MFI on Site Management and Policy Formulation in the PA.</p>
<p>3) Presentation of the Manual of Operations by Mr. David which included among others the i) forty seven (47) PAMB En Banc members and members of the seven (7) Technical Working Committees of PAMB, and ii) issue raised by Mr. Pastores to rephrase the "3 representatives from NGOs/POs to 3 representatives from NGOs and another 3 from the POs."</p>	<p>PAMB En Banc composition/membership should be in accordance with Section 11 of RA 7586 as amended by RA 11038 and DAO 2019-05. PCSD may be included as honorary member of the PAMB En Banc in consonance with the SEP Law supported by PAMB Resolution. The members of the seven (7) Technical Working Committees should be in accordance with BMB Technical Bulletin No. 2017-04 which states that <u>"each TWC shall be composed of at least five (5) members whose membership comes from the PAMB En Banc."</u></p>

4) Resolution No. 026, Series of 2020 <i>"A Resolution Adopting and Approving the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) Protected Area Management Plan (PAMP) for 2020 to 2029"</i>	- Kindly review and rectify the MISSION and VISION in the Minutes and Resolution as this might have been interchanged or just a typographical error and RESUBMIT for approval.
5) Small-scale quarry application of Mr. Ronie Pacada at Sitio Langeb-langeb, Barangay Aberawan, El Nido	- Quarrying is prohibited in protected areas (Section 20.q of RA 7586 as amended) in addition to the fact that, based on the PAMO report the proposed quarry area is adjacent to the established BMS sites and flood-prone thus not classified as quarry area in accordance with RA 7942 (Mining Act of the Philippines).
6) SMART Telecommunications and DPWH Projects	<ul style="list-style-type: none"> - These projects are subject to SAPA application pursuant to Section 25 of RA 7586, as amended by RA 11038 and its IRR, DAO 2019-05. - For telecommunications, these should likewise be in compliance with DENR Memorandum dated December 16, 2020 of USEC for Field Operations and Environment, Atty. Juan Miguel T. Cuna, CESO I on <i>"Processing of SAPA Applications Involving Communication Towers and Facilities."</i> - PAMB is tasked with <i>"overseeing the management of ENTMRPA"</i> (Section 11-A.a, RA 7586, as amended by 11038 and its IRR, DAO 2019-05, NOT "assuming as the "super guardian of all El Nido matters" as stated by one of the members of the Management Board. - PAMB should be supportive of LGU development projects but at all times be on guard on potent destructive activities/ projects that pose threat to the balance of ecosystem/biodiversity within and around ENTMRPA.
