This is in connection to our letter dated 22 August 2022 informing your Office of the simultaneous Joint Verification Survey (JVS) activities for the following: (i) Coron Bay Reclamation; (ii) Coron Market; and (iii) Fernville Subdivision to be conducted on 26 September to 08 October 2022.

May we respectfully request that a Survey Order (SO) be issued in the name of **Engr. Joemarie S. Caballero** with PRC License No. 0008473 issued on 30 November 1979, as PRA's Geodetic Engineer that will lead and conduct the final boundary and topographic survey of the Coron Bay Reclamation, subject of PRA's total forfeiture, to be witnessed by representatives from the Provincial Environment and Natural Resource Office (PENRO) – Palawan and/or Community Environment and Natural Resources Office (CENRO) - Coron, Palawan. We would appreciate your timely issuance of the subject Survey Order.

In addition, this Agency would again seek assistance from the same Survey Team of your Office for the conduct of a preliminary survey on the Coron Market and Femville Subdivision to be witnessed by Representatives from PENRO Palawan and PRA. Please provide us with your focal person and his/her contact number for the purpose of coordination on this matter.
