In relation to the Memorandum dated September 13, 2023, issued by the OIC-Regional Executive Director Felix S. Mirasol, Jr., CESO IV in celebration of Civil Service month for the year 2023, this office conducted various activities as compliance and to support the 123rd Anniversary of the Philippine Civil Service.

As per the memorandum, we were instructed to conduct the following activities:

- 1. Health and Wellness Week
- 2. Financial Institutions and Livelihood Week (KADIWA)
- 3. Government Week

As part of the Health and Wellness Week, the DENR-CENRO Sablayan had Zumba activities conducted for two consecutive Mondays after the flag-raising ceremony joined by all employees and facilitated by assigned sections. Zumba dance has several health benefits, such as getting into shape, boosting our heart health, and increasing our mental well-being. The employees obviously enjoyed the Zumba dances that had been prepared.











Also, this office facilitated a blood-letting activity in coordination with the Red Cross-San Jose Chapter on September 29, 2023. There are several personnel who were very willing to donate blood for the benefit of those who are in need. Unfortunately, some of them did not pass the pre-screening for eligible personnel as they had mild illness during that time. Nevertheless, it was indeed a success as the Red Cross collected 3.150 cc or seven (7) units of blood.







As to Government Activity Week, it was combined with the scheduled meeting with the stakeholders pertaining to the forthcoming application for Residential Free Patent, particularly in Barangay Payompon, Mamburao, Occidental Mindoro. In the said activity, concerned personnel discussed forestry matters, permitting such as chainsaw registration, policies and requirements on Residential Free Patent Applications, and Gender and Development. It was attended by some Barangay Officials and barangay stakeholders and the various employees of DENR-CENRO Sablayan.
