2017 OF THE UNDERSECRETARY FOR CLIMATE CHANGE SERVICE REGARDING THE ISSUANCE OF DEMAND LETTER TO ALL FOREST TENURE INSTRUMENT HOLDERS WITHIN

This has reference to the Regional Forestry-related revenue collection for Fiscal Year 2022 vis-à-vis the projected revenue for the same year.

Analysis of the projected revenue vis-à-vis revenue collection data for FY 2022 indicated that there are only 49.41% Revenue Collection from the Government Share, User's Fee and Rental of FLAg, FLAgT, FLGMA, SIFMA, IFMA, SLUP, OLP/SPLULA. Hence, a deficit of 50.59% in the collection of tenure fees (Government Share/Rental/User's Fee) for the forestry sector. Below is a table of the Regional Revenue Collection data and projected revenue for immediate reference.

On 26 September 2017, a Memorandum was issued by the Undersecretary for Climate Change Service on the issuance of demand letter to all forest tenure instrument holders within administrative jurisdiction of DENR Field Offices (copy attached). Based on the Memorandum, all the DENR Regional Directors were reminded that failure to pay rental/user's fee, government share and other required fees after they become due and demandable is among the grounds for suspension and/or cancellation of the agreement, pursuant to the terms and conditions thereof, and existing laws, rules and regulations.

In line with this, certain provisions of the Memorandum dated 26 September 2017 are hereby reiterated for immediate action and compliance, to wit:

- Issue demand letters to delinquent occupants/lessee/holders who have not settled their outstanding payments for the FY 2022; and
- 2. Cancel the agreements for the delinquent occupants/lessees/holders for those who failed to pay the annual lease rental for two (2) consecutive years.

If the holder/lessee seeks reconsideration from the cancellation, DENR may grant such request, subject to full payment of unpaid amount plus surcharges including penalty.

This has reference to the recommendations of the Commission on Audit (COA) contained in its Consolidated Annual Audit Report for the year ended December 31, 2015 regarding uncollected/unrealized income from foreshore areas, forest lands used for grazing purposes and patrimonial properties.

It may be mentioned that per Memorandum dated 17 February 2017 of then Undersecretary Marlo D. Mendoza (copy attached), you were directed to issue demand letters to all holders of forestry tenure instruments within your administrative jurisdiction. Likewise, you were reminded that failure to pay rental/user's fees, government share and other required fees after they become due and demandable is among the grounds for the suspension and/or cancellation of the Agreement, pursuant to the terms and conditions thereof, and existing laws, rules and regulations.

In this regard, the aforesaid Memorandum of Undersecretary Mendoza is hereby reiterated. Hence, you are directed to undertake the following:

- 1. On expired forestry tenure instruments including FLGLAs/FLGMAs:
 - a. Issue demand letter to the former lessee/holder to vacate the area/property;
 - b. Take possession of the property on behalf of the DENR and take appropriate measure to protect the same;
 - c. Conduct comprehensive assessment to determine the best land use of the area;
 - d. Make public notices that the area is now open for application for forestry purposes and/or consider the same under the National Greening Program; and
 - e. Forfeiture all improvements introduced and found in the area in favor of the government.

- 2. Delinquent occupants/lessees/holders (Those occupants who failed to pay the annual lease rental for 2 consecutive years)
 - a. Cancel the Agreement:
 - If the holder/lessee seeks reconsideration from the cancellation, DENR may grant such request, subject to full payment of unpaid amount plus interest including penalty;
 - b. Take possession of the property on behalf of the DENR and take appropriate measure to protect the same:
 - c. Conduct comprehensive assessment to determine the best land use of the area;
 - d. Make public notices that the area is now open for application for forestry purposes and/or consider the same under the National Greening Program; and
 - e. Forfeiture all improvements introduced and found in the area in favor of the government.

Please submit your compliance on the same to this office within fifteen (15) working days from receipt of this Memorandum, copy furnished the Director, Forest Management Bureau.
