ORDER

Filed before this Court is an Information charging the accused **MARK BALDONADO y Flores, MARCELINO BAGARINO y Sumigin, and ALFREDO BACORRO JR. y Doctor**, with the crime of Violation of Section 77 of PD 705 for, *'having in their possession and control eight (8) pieces 1x8x6 gmelina lumber, two (2) pieces 4x6x6 gmelina lumber, and four (4) 2x11x3 ipil lumber with a total volume of 78 board feet valued at P 3,950.00, without authority from the Secretary of Environment and Natural Resources'*. Released on bail and assisted by their counsel from the Public Attorney's Office, they all pleaded not guilty when arraigned.

When this case was called for hearing, Atty. Ryan D. Agoot from the Public Attorney's Office represented the accused, while the Provincial Prosecutor Roberto Santos represented the government.

Thereupon, accused, through counsel, moved to be allowed to enter into a plea bargain agreement and to plead guilty to a lesser offense and which lesser offense they proposed to plead guilty to is necessarily included in the offense charged. The arresting officer PEMS Romeo D. Molino of the San Jose, Occidental Mindoro, Municipal Police Station, Atty. Sancho Niedo, CENR-DENR, and the Provincial Prosecutor interposed no objection to the motion.

Therefore, the accused were arraigned for the lesser crime of Simple Theft under Article 308 in relation to Article 309 of the Revised Penal Code, by reading the Information to them in a language or dialect they know and understand, assisted by their counsel from the Public Attorney's Office. Thereafter, **MARK BALDONADO y Flores, MARCELINO BAGARINO y Sumigin, and ALFREDO BACORRO JR. y Doctor**, all entered a plea of guilty.




Wherefore, judgment is hereby rendered finding the accused **MARK BALDONADO y Flores, MARCELINO BAGARINO y Sumigin, and ALFREDO BACORRO JR. y Doctor** guilty beyond reasonable doubt of the crime of 'Simple Theft', defined and penalized under Article 308 in relation to Article 309 of the Revised Penal Code. They are hereby sentenced to each serve the penalty of Arresto Mayor to its full extent or imprisonment of One (1) Month and One (1) day to Six (6) Months.
