This pertains to your Memorandum dated 08 September 2023 requesting for the status of the applications for FLAgT of the following: Asia Grand View Hotel, Inc.; Palawan Cove Corporation; Island Resort Group (Leisure) Corporation; and One Cashew Leisure Ventures, Inc. all located in the Province of Palawan. DENR MIMAROPA is also requesting that the entire document folders of the said applications be returned to the Regional Office.

Relative thereto, please be informed of the following, to wit:

1. Asia Grand View Hotel, Inc. - there is no available document and record from this office relative to this FLAgT application.

2. Palawan Cove Corporation (PCC)

The entire folder of documents relative to the PCC application for expansion of FLAgT No. 01-2012 was returned to DENR MIMAROPA Region per Memorandum dated 19 June 2017 of then Assistant Secretary for Staff Bureaus (copy hereto attached). Pursuant to the said memorandum, DENR MIMAROPA was instructed to prepare status report and Completed Staff Work (CSW) with categorical recommendation relative to the aforementioned request for expansion of the issued FLAgT to the PCC.

Also, the FMB was furnished of letter dated 16 October 2019 from DENR MIMAROPA Region addressed to Ms. Leslie Ann T. Yapkianwee, Business Manager and Authorized Representative of Palawan Cove Corporation relative to the result of compliance monitoring with the terms and conditions of FLAgT No. 01-2012 of PCC and the final demand letter regarding the PCC's violations.

3. **Island Resort Group (Leisure) Corporation (IRGL)** - The application for the SLUP conversion to FLAgT of IRGL was endorsed to the Undersecretary for Field Operations per FMB Memorandum dated 27 November 2018.

It is well to note that the FLAgT was already signed by the Undersecretary for Field Operations however, the IRGL refuses to sign the said agreement because there will be back rentals to be settled.

Further, monitoring was conducted in March 2020 by concerned DENR MIMAROPA Field Offices and it was observed that there is no major developments and construction made within the SLUP area.

4. **One Cashew Leisure Ventures, Inc. (OCLVI)** - The Undersecretary for Field Operations sent a Memorandum dated 03 June 2019 to DENR MIMAROPA Region relative to the FLAgT application of OCLVI, the same is in reference with the letter dated 22 April 2019 of OCLVI.

A Technical Meeting was held on 25 June 2019 on the matter attended by OCLVI, concerned DENR MIMAROPA Region Offices, and FMB the highlights of the said meeting is attached hereto for your information and reference.


