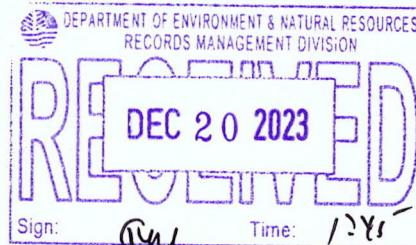

In response to your letter dated 03 November 2023 begging this office to implement Executive Order No. 682, s. 2007 designating Calapan City as the Regional Center of Region IV-B, please be informed that we are exerting all efforts to implement Republic Act No. 10879 and its Implementing Rules and Regulations (IRR). Said law renamed Region IV-B to MIMAROPA Region, and its IRR established Calapan City as the Regional Center.

We have already signified our interest and requested the NEDA-MIMAROPA for lot allocations for DENR, EMB and MGB in the Regional Government Center. We have also requested from the DENR Central Office funding for the transfer of the Regional Office to Calapan City, as one of the options forwarded to ensure full operation of the office amidst the threat of earthquake.

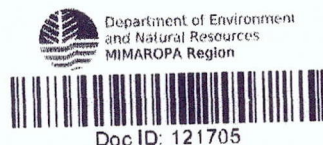
Attached for your ready reference are the following documents:
