In line with the Department's objective to bring environmental protection closer to the public and other stakeholders, the Bureau is producing Coffee Table Book on Philippine Heritage Trees as part of our Information, Education, and Communication (IEC) campaigns.

The project hopes to establish a link between the present and the past by creating an original, interesting, and engaging book, allowing people to gain insights into history via trees. This coffee table book will also educate and extend other people's perspectives on the significance of our historic trees, which are gradually fading.
