- 5) Proof of Ownership (Title or Deed of Donation)
- 6) Geo-hazard Clearance issued by the Mines and Geosciences Bureau
- 7) Earthquake Hazard Assessment from DOST-Philvocs
- 8) DPWH recent standard cost estimates
 - *(Section 7, National Budget Memorandum No. 142 dated 12 January 2022)
 - *This might be one of the following:
 - a. Endorsement Memorandum from DPWH
 - b. Cost Estimates certified by the DPWH
 - c. Construction Materials Price Data (CMPD) requested from the DPWH

*NOTES:

- a. Minor repairs such as repair/renovation of office rooms are not required to submit DPWH recent standard cost estimates
- b. Using the same Geohazard Certification and/or Earthquake Hazard Assessment of projects in one location such as two separate office renovations within the same building or area is allowed.
