This pertains to the above-cited subject requesting this office to provide updates and issue certification relative thereto.

First, as regards the Order to Furnish a copy of your Decision involving **MIMAROPA AAP CASE NO. 006**, this office is still in the process of identifying the Court where the criminal case was filed, *if any*.

Per review of records, a complaint was filed before the Office of the City Prosecutor (OCP) Calapan with **NPS Docket No. IV-13-IN-V-215-00284**. The complainant involved is the National Bureau of Investigation-MIMAROPA Regional Office, NBI Bldg., Sitio Cuatro Aguas, Barangay Sta. Isabel, Calapan City, Oriental Mindoro. This office coordinated with the concerned personnel of the said agency but was informed that the OCP Calapan dismissed their complaint. Accordingly, a letter to City Prosecutor Dorina H. Joya was sent to verify the information.¹ *This office is still awaiting reply from the latter.*

Second, as regards the Request for Certification, **No Motion for Reconsideration or Notice of Appeal was filed with this office involving MIMAROPA AAP CASE NO. 006.**

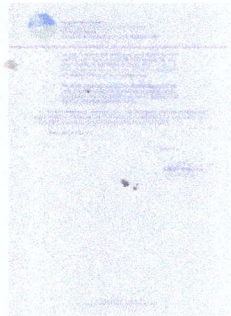
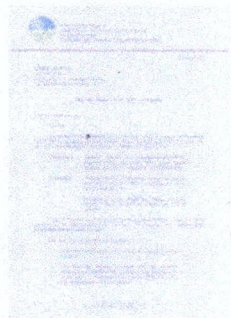

This pertains to the Letter dated 17 March 2023 previously sent by this office.

We are sending this email to respectfully inform you that there has been a mistake in the citation of RED Decision (MIMAROPA AAP CASE NO. 006).

The correct ruling of the RED is as follows:

"Wherefore, foregoing premises, considered, a ruling is hereby rendered:

1. The seized eighty-one (81) pieces of Mahogany lumber are **CONFISCATED** in favor of the government to be disposed of in accordance with existing DENR law, rules and regulations governing the matter; and
2. The CENRO concerne is directed to **FURNISH** a copy of this Decision to the Court where the criminal case is pending for their consideration, record, and reference, and submit updates to this Office for record and monitoring purposes."

As regards No. 2, we would like to humbly inquire whether a criminal case was filed against respondents of **NPS Docket No. IV-13-IN-V-215-00284** and where it was raffled or any relevant information thereto.
