Furthermore, being declared for such purpose and assuming that there are areas within the facility classified as Alienable and Disposable land still we cannot accept, process and conduct subdivision surveys because there is contrary to existing policies and laws observed by the Government.

Nonetheless, we appreciate the information provided by the concerned citizen. It would be a big help in our part if he/she can provide the name/s of the personnel engage in illegal activities so that proper sanction can be imposed.
