Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case entitled *Department of Environment and Natural Resources –versus- Crispin Maansig Yayag* for violation of R.A. 9175, as amended. Please be informed that Administrative Hearing was conducted last March 13, 2023, in accordance with Item 2, Section 7 of DAO 97-32 which was attended by the respondent, with the following observations:

- 1. Based on the spot report of the Municipal Police of Bansud, they received a call from a concerned citizen and reported that a person was cutting a coconut tree using a chainsaw at Barangay Proper Tiguisan, Bansud, Oriental Mindoro.
- 2. MPS Bansud immediately went to the area to verify the information. They saw Crispin Maansig Yayag in the act of cutting a coconut tree.
- 3. MPS Bansud asked him if he has a registration for the use of the chainsaw. He responded that the registration was already expired.
- 4. An administrative hearing was conducted after the turn-over of the documents from the Municipal Police of Bansud.
- 5. During the administrative hearing, Crispin Yayag admitted that he cut the coconut tree using the said chainsaw. He only did it because his friend asked for his help. He reiterated that the registration of the chainsaw is already expired and is in the name of Catly Robay to whom they bought it.
- 6. The subject chainsaw was turned over by the apprehending officers to the nearest authorized Seizure Officer pursuant to Section 3 of DAO 97-32.

The undersigned after having reviewed the documents at hand, the statements of the respondent, and the Administrative Hearing conducted, determines that the STHIL Chainsaw bearing Serial No. S-223915823 has expired legal documents/papers from the DENR to warrant the use of the same. The possession and use of such to cut trees violate R.A. 9175.

In view of the foregoing, these are the findings and recommendations of the hearing officer:

CRISPIN YAYAG, the respondent for CENRO Case No. 2023-01, violated R.A. 9175. The STIHIL CHAINSAW **shall be forfeited** in favor of the government and **shall be forfeited** in favor of the government.

This case has been filed at Regional Trial Court with Criminal Case No. CR23-12212 for violation of R.A. 9175.






