

Dear Hon. Secretary:

We are writing to formally request the inter-Agency Task Force to review, evaluate and provide assistance to certain complaints of foreign nationals and overseas Filipinos regarding the fraudulent Regatta Bay Project situated in Puerto Princesa, Palawan supposed to be undertaken and implemented by Cabanilla Marketing and Development Corporation (CMDC).

This request is based on the Inter-Agency Task Force's Joint Memorandum Circular No. 1, Series of 2021, signed and agreed on July 2nd, 2021, specifically its preamble and Section 9 regarding the roles of the member-agencies.

The complaints we have received, formalized in the attached complaints, pertain to the non-delivery or non-construction of purchased units and the alleged fraudulent practices of CMDC as the developer of the Regatta Bay Project. Summarized hereunder are the names and nationality of complainants and the payments they have made for residential units which have not been delivered or constructed, to wit:

Our investigation has further revealed that CMDC has failed to comply with the key conditions of the License to Sell No. 033056 issued to them on March 21st, 2018, by the former Housing and Land Use Regulatory Board (HLURB). These conditions include, but are not limited to, the completion of the project in accordance with the approved development plan, the maintenance of common facilities, the registration of the instrument relative to any sale with

the Register of Deeds, and the delivery of titles free from liens and encumbrances to fully paid buyers.

Furthermore, we believe that CMDC has committed numerous violations of Presidential Decree No. 957, regulating the sale of subdivision lots and condominiums, and related laws. Our investigation has also revealed that CMDC never disclosed in its marketing brochures that CMDC is not the real owner of the Regatta Bay Project. It is actually a joint venture between CMDC and one Ms. Katyryn D. Carbonero where the former is the developer and the latter as Project Owner. CMDC never owned the land upon which Regatta Bay was conceived and sold but Ms. Carbonero, as seen in both the License to Sell and the Certificate of HLRUB Registration No. 028669 dated 21 March 2018.

Given the circumstances, we believe that CMDC and its principal agents and officers are guilty of violating PD 957 and have committed the offense of estafa through deceit or misappropriation. Despite contrary opinions made by the Office of the City Prosecutor of San Juan City, we believe that these cases warrant a revisit by the Task Force as they have national implications and effect on the reputation of the country as a tourist and investor destination.
