Respectfully endorsing the memorandum report from the Conservation and Development Section (CDS) dated January 30, 2023 regarding on the conducted nest and habitat monitoring of Philippine Cockatoo (*Cacatua haematuropygia*) within Iwahig Prison and Penal Farm (IPPF) particularly at the lowland forest of Barangay Sta. Lucia part of Barangay Luzviminda and Barangay Montible, Puerto Princesa City.

During the 2-days monitoring activities, four (4) nest trees were monitored and visited consisting of three (3) sites in Sta. Lucia KM. 24 and one (1) site in Barangay Montible-Menor & Tagtalaba. There are seven (7) heads of Philippine Cockatoo observed flying around the nest trees in Barangay Sta. Lucia areas and two (2) heads of Philippine Cockatoo and Blue-naped Parrot observed in Barangay Montible nest trees.

Please be informed that the undersigned together with FR Rhyan Domondon joined/Assisted the team of KFInc. Speareheaded by Matt Brian P. Ong Science Research Assistant (SR) KFI for January 2023 nest and habitat monitoring of Philippine cockatoo as the year's breeding season for cavity nesters has started within the lowland forested area of IPPF-BUCOR located at Bgry. Sta. Lucia and Montible, PPCity.

On January 24, 2023 the undersigned together with FR Rhyan Domondon proceeded at the office of KFInc.to joined the team Spearheaded by Matt Brian P. Ong in conducted nest and habitat monitoring of Philippine cockatoo within the forested area of IPPF-BUCOR, Bgy. Sta Lucia there were three (3) identified Bayoso trees with 75, 80 and 85 cm. and dia. Monitored nesting site as the year's breeding season the team observed seven (7) heads cockatoo roving around on the top of canopy of last tree measured 85 cm. & dia. with geotagged 9'41'57''N 118''40'11''E then the team moving back proceeded at KFInc Office Sta. Monica, PPCity. On January 27, 2023 The team Proceeded again at the lowland forested area of (minor) Bgy. Montible IPPF-BUCOR in conducted nest and habitat monitoring of Philippine cockatoo the team hiked at around 11/2 hour to reached the area of the nesting site one (1) Apitong tree with 70 cm. and dia.were monitored we have observed also two (2) heads of Phlippine cockatoo and two heads (2) of Parrot seen roving around on the top canopy of Apitong tree with geotagged 9'41'13"N 118'38'7"E then the team moving back at the office of KFInc, Purok El Rancho, Sta. Monica, PPCity.
