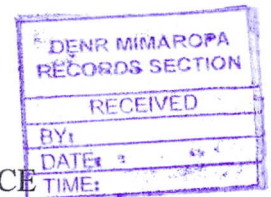

Greetings!

This pertains to the Complaint of Spouses Arthur and Ma. Soledad Josefa Bada- Lequiron against Engr. Dale Garcellano for violation of the Clean Water Act (RA 9275). The Complaint was sent to the Honourable DENR Secretary, the Municipal (Taytay) Health Office, and the Punong Barangay of Poblacion, Taytay, Palawan. It also reveals that your Office, like this Office, was furnished with a copy of the Complaint, so is this coordination.

Upon receipt in this Office of the copy of the Complaint, there was a coordinated verification at the area right away and our representatives found the allegation is true. Knowingly, the Office of the Punong Barangay initiated a conference between the parties and there was an initial settlement reached for Mr. Garcellano to fix his septic tank.

The following were the recommendation of our Environmental Management Bureau representative insofar as the role of the LGU:

“xxx”

1. It is recommended that the local government unit (LGU) of Taytay, Palawan act on this urgently in compliance with DILG Memorandum Circular No. 2019-62 Section 2.0 and 3.0 and also Republic Act 7160, Section 17.
2. It is also recommended that the Licensing Department of the LGU check for the permits of the boarding house if it is operating as a business establishment. xxx”

In view hereof, we hereby seek the intervention of your Office. Thank you.
