Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated March 7, 2023 relative to the above-cited subject.

Per memorandum, Mr. Benjamin Ermio, Jr. claiming to be the owner of Hyundai H-100 WITH Plate No. RPD-302. He presented the Official Receipt of the vehicle under the name of Danilo R. Tojong and the Deed of Absolute Sale between Trespolo Vergara Agustin and Mr. Benjamin Ermio, Jr. on April 19, 2021. He also executed an affidavit to attest the veracity of his statements.

Further, the CENRO Office identified the individuals allegedly involved in the illegal transport of Ipil lumbers that was apprehended. As a result, the said office will conduct administrative hearing in relation to Section 07 of DAO 1997-32.

We concur with CENRO recommendation involving this case to be put on hold until the hearing is finally concluded.

This is in connection with the Memorandum dated February 03, 2023 directing this office to coordinate with the Land Transportation Office (LTO) for the identification of the registered owner of the apprehended conveyance.

Please be informed that on November 7, 2022, Mr. Benjamin Ermio, Jr. appeared in this office claiming to be the owner of Hyundai H-100 with Plate No. RPD-302. He exhibited the Official receipt of the vehicle under the name of Danilo R. Tojong and the Deed of Absolute Sale between Trespolo Vergara Agustin and Mr. Benjamin Ermio, Jr. on April 19, 2021. He also executed an affidavit and to attest the veracity of his statements.

In the affidavit, he identified individuals allegedly involved in the illegal transport of ipil lumbers that was apprehended by this Office. This Office is verifying the persons involved since the area is identified as hot spot and it seems that there is a connivance among the residents. Mr. Ermio did not return after he submitted the affidavit. When he went to this Office he mentioned that he received death threats coming from the individuals he identified as intimidation to prevent him from reporting them to DENR Office. Hence, this Office is taking extra caution in identifying the persons involve since this is not the only incident reported and apprehended coming from the said area.

As of this date, the owner of the vehicle and the alleged perpetrators were already identified. As a result, this office is set to conduct administrative hearing involving this case.

In line with this, we are requesting that our previous recommendations involving this case be put on hold until the hearing is finally concluded.

Attached are the affidavit and the vehicle documents submitted by Mr. Ermio for your information and records.

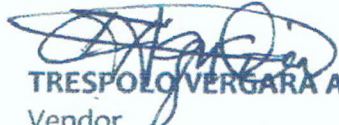

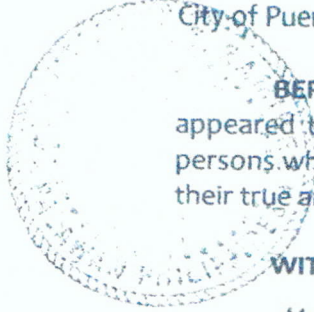
