

The twenty (20) pieces of Panasan lumbers species (200 board feet) and six (6) pieces of round timber of Ipil species (0.40 cubic meter) were apprehended by the DENR CENRO Brooke's Point Quick Response Team, MENRO Personnel, MPS and PMFC of Sofronio Española, Palawan at Sitio Pasi, Barangay Pulot Interior, Sofronio Española, Palawan on November 12, 2022.

The said apprehended items are now under the custody of MENRO Sofronio Española, Palawan. Further, these apprehended items are now deposited at MENRO Sofronio Española compound for temporary safekeeping.

The twenty (20) pieces of Panasan lumbers species (200 board feet) and six (6) pieces of round timber of Ipil species (0.40 cubic meter) are declared **abandoned** items, or **without claimant**, as the case maybe.
