SUBJECT : CONDUCT OF COMMUNICATION, EDUCATION AND PUBLIC AWARENESS REGARDING THE INVOLVEMENT OF FOREST COMMUNITIES IN ENVIRONMENTAL PROTECTION.

In line with the P/A/P involvement of forest communities in forest protection activities the Enforcement Monitoring Section of CENRO San Jose, Occidental Mindoro had conducted Communication, Education and Public Awareness (CEPA) Campaign at Brgy. Naibuan, San Jose, Occidental Mindoro last February 23, 2023, which was attended and participated by 65 individuals (59 males and 6 females) of Sitio Leaders, Brg. Naibuan LGUs, IP's communities, Municipal Environment and Natural Resources (MENRO), and Philippine Army.

Please be informed that the activity started at around 8:30 in the morning thru an opening prayer led by Forest Protection Officer Sheryl Sajot and followed by welcome remarks from the Brgy. LGU is represented by Kag. Marissa Lucena wherein expressed her gratitude towards the DENR employee, Philippine Army, Municipal Environment and Natural Resources Officer (MENRO) of San Jose, and IPs from Brgy. Naibuan, San Jose, Occidental Mindoro for facilitating such an event to involve the forest communities in protecting their environment and natural resources.

CENR Officer Efren L. Delos Reyes had given an inspirational message and expressed his gratitude towards the Forest Communities and BLGUs of Brgy. Naibuan, and other partner agencies the MENRO, Armed Forces Philippines for their effort in the protection of the environment and natural resources within their ancestral domain. CENR Officer Efren also cited the importance of the Environmental Laws especially to the minorities because they served as a protection not only for the environment but also for themselves.

That, MENRO Representative Engr. Anna Marie Onilla discussed the salient features of Republic Act 9003 "Solid Waste Management", the proper segregation of waste from biodegradable, to residual and recyclable. Recyclable waste can be a source of income and biodegradable waste will be an alternative fertilizer for their plants and residual waste will be collected by the MENRO and it will be appropriately disposed of.

A video presentation regarding Climate Change, Forest degradation, and Forest is Life was played by the undersigned. It was then explained that protection of the environment must be implemented to avoid and lessen the problems that were being encountered not only for today but for future generations, where our lives depends on the environment.

Atty. Sancho Nieto III discussed the topics on the salient features of Presidential Decree 705 (Forestry Code of the Philippines), RA 9175 (Chainsaw Act) and RA 7161 –banning the cutting of mangroves. He also presented the penal provisions of the said laws.

After the presentations, the forum was opened where certain questions about kaingin making, MRF, use of a chainsaw and registration, and cutting permits were raised.

Then it comes to the recommendations such as a construction MRF, planting more trees and preventing illegal cutting around the source of water, planting of fruit trees than creating more kaingin and disseminating the information and knowledge that they have learned to their tribes was acknowledged by the participants.

The activity was then adjourned at 4:00 in the afternoon with a closing message from Forester Jomar B. Serquiña where he expressed his gratitude to the efforts of each participants in attending the said activity and looking forward for their effort and involvement in protecting the Environment and Natural Resources.

**MINUTES IN THE CONDUCT OF COMMUNICATION, EDUCATION CAMPAIGN
AND PUBLIC AWARENESS REGARDING THE ENVIRONMENTAL PROTECTION
WITH THE INVOLVMENT OF FOREST COMMUNITIES ON FEBRUARY 23, 2023
AT WEAVING CENTER OF BARANGAY NAIBUAN, SAN JOSE,
OCCIDENTAL MINDORO**

Preliminary activities

The program proper was facilitated by Forest Technician II Loren Kaye A. Garcia and activity was opened through an opening prayer lead by Forest Protection Officer Sheryl O. Sajot. It was immediately followed by a welcome remarks given by BLGU Kag. Marissa M. Lucena in the absence of Brgy. Captain May-at Luzon in which she welcomes the participants and expresses her gratitude towards the DENR employee, Philippine Army, Municipal Environment and Natural Resources Officer (MENRO) of San Jose, and IPs from Brgy. Naibuan, San Jose, Occidental Mindoro. Also, Brgy. Kagawad Angelito E. Ero expressed his gratitude and belief in the importance of the objective of the activity to strengthen the campaign towards the protection and conservation of the environment and natural resources.

Afterward, a message of gratitude was given by CENR Officer Efren L. Delos Reyes, emphasizing the exerted efforts of LGU's, BLGU's of Barangay Naibuan, IP's communities for the protection, and conservation of the environment and natural resources. He also mentioned the Environmental Laws to each individual especially those of the minority class of society as the law will serve as their protection against powerful individuals who will abuse their powers against those living in the low class. Also the role of the Indigenous People (IP's) how they should take care of the environment as well as the role and functions of DENR in protection the ancestral lands of the Indigenous People(IP's).

A Roll Call and introduction of the participants was executed by Forest Technician II Loren Kaye A. Garcia, in which fifty nine (59) are males and six (6) are female were present.

Part I: Meeting Proper

1. RA 9003 (Solid Waste management)

RA 9003 or Ecological Solid Waste Management was presented by Engr. Anna Marie Onilla of MENRO San Jose in the absence of Ms. Iny Lourdes S. Peroy. She mainly discussed the importance of this Act such as Classification of Wastes and Solid Waste Management Evolution. Also, the role of DENR under this Act as to provide technical and other capability building assistance and support LGU's and other private sectors. Certainly discussed the role of the Barangay regarding the conduct of segregation and collection of solid waste from biodegradable, compostable and reusable wastes, as well as the role of the Municipality or city that should be responsible for the collection of non-recyclable materials and special wastes.

These are the Sections of this Act that Ms. Onilla clearly stated as to wit:

• Section 21-Segregation of Waste

Mandatory Segregation of solid Waste-The LGUs shall evaluate alternative roles for the public and private sectors in providing collection service, type of collection system, or combinations of systems, that best meet their work.

• Section 23-Requirements for Collections of Solid Waste

Minimum standards and requirements for the collection of solid waste. All collectors and other personnel directly dealing with collection of solid waste shall be equipped with personal protective equipment to protect them from the hazards of handling solid wastes. Necessary training shall be given to the collectors and personnel to ensure that the solid

wastes are handed properly and in accordance with the guidelines pursuant to this Act, and collections of solid waste shall be done in a manner which prevents damage to the container and spillage or scattering of solid waste within the collection vicinity.

- **Section 32-Establishment of LGU MRF's**

There shall be established a Material Recovery Facility (MRF) in every barangay or cluster of barangays. The facility shall be established in a barangay-owned or leased land or any suitable open space to be determined by the barangay through Sanggunian.

- **Section 33-Guidelines for Establishment of Materials Recovery**

Materials recovery facilities shall be designed to receive, sort, process and store compostable and recyclable material efficiently and in an environmentally sound manner.

- **Section 37-Prohibition Against the Use of Open dumps for Solid waste**

No open dumps shall be established and operated, nor any practice of disposal of solid waste by any person, including LGUs which constitutes the use of open dump sites for solid waste be allowed after the effectivity of this Act. Provided that within three (3) years after the effectivity of this Act, every LGU shall convert its open dumps into controlled dumps, no controlled dumps shall be allowed five (5) years following effectivity of this Act.

At the end of presentation. Ms. Onilla showed some pictures of examples of stated above subject.

2. Video presentation

Chief, EMS Augreth Saligumba played a video clip to address the prevailing Environmental issues that this generation is continuously battling such as climate change, global warming and deforestation.

3. Salient Features of Presidential Decree 705, Chainsaw Act of 2002(RA 9175), and RA 7161

a. Salient Features of PD 705

Atty. Sancho Niedo III discussed the Presidential Decree 705 or the Revised Forestry Code of the Philippines which he first mentioned its definitions together with the Criminal Offenses and Penalties involved in the said law. With regards to this, he particularly discussed Section 68, PD 705 Cutting, gathering and/or collecting timber or other products without license states that any person who shall cut, gather, collect or removed timber or other forest products from any forest land or timber from alienable and disposable public lands, or from private lands, without any authority or possess timber f other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code.

He then specify to secure a permit from the Office of DENR and the barangay has no authority to give a permit to cut instead only a Certification stating that the permittee had planted trees within their titled land but in the case of Brgy. Naibuan which is under the CADT area they should have ADSDDP which will secure at NCIP Office.

b. Chainsaw Act of 2002(RA 9175)

Atty. Sancho Niedo III of DENR-CENRO San Jose discussed the topic on Chainsaw Act of 2002 (RA 9175) or an An Act regulating the ownership, possession, sale, importation and use of chainsaw, penalizing violations thereof and for other purposes.

He encouraged everyone to secure a Chainsaw Registration from the Office of the DENR and which has a validity of 2 years

c. Republic Act 7161

Atty. Sancho Nieto III of DENR-CENRO San Jose also gives a slight discussion on Republic Act 7161: It's about Mangrove Trees. No person, natural or juridical, shall girdle, burn or possess any mangrove species or any part thereof without a permit from the concerned government agency and/or SEP Clearance from the PCSD.

Part II. Open forum

1. Kag. Juan A. Anggin: We are about to make a kaingin and there were trees that need to be cut is it illegal to cut the said trees?
CENRO: Yes, It is illegal and a violation if we cut those trees that had already grown in the area. Instead of cutting trees plant more fruit-bearing trees and you will benefit in the future.
2. Kag. Marissa M. Lucena: Can we harvest those trees that were planted during the NGP in our area?
CENRO: Those trees that were planted during the NGP, we could not immediately harvest since you as our partners, were paid from the establishment of the nursery until the maintenance. The trees were planted to serve as protection and to bring back the deforested forest.
3. Kag. Marissa M. Lucena: What does MRF mean?
Engr. Anna Marie Onnilla: Material Recovery Facility where the waste was segregated into residuals and recyclable. The residual waste will be collected by the MENRO and the recyclable materials will be sold by the barangay that serves as their extra income. While the bio-gradable such as leaves, fruit peels, and branches will be dumped in a composed pit and it will serve as a natural fertilizer for the plants.
4. Kag. Marissa M. Lucena: How to make an alternative fertilizer?
Engr. Anna Marie Onnilla: With the use of used tires, or an open pit we can put all those biodegradable materials/waste to be decomposed and it will be serving as a natural fertilizer.
5. Kagawad Angelito Ero: Can we cut and harvest Coconut within our area?
Forester Augreth: Issuance of Cutting permit for coconut is not under the jurisdiction of the DENR. Philippine Coconut Authority is the lead agency that issues the necessary documents for cutting down coconut trees. However, a need for a registered chainsaw at the DENR will be used.
6. Kagawad Angelito Ero: Is there a registered chainsaw for the coconut?
Forester Augreth: All chainsaws must be registered to the Department before use in the cutting of trees and coconut.
7. Kag. Roger A. Balombong: Can we register a chainsaw?
Atty. Sancho, III: Yes, you can bring the required requirements and the chainsaw to the DENR office for verification and inspection.
8. Kag. Angelito E. Ero: Where can we buy a registered chain saw
Atty. Sancho, III: There is no such thing as registered chainsaw, the chainsaw must be bought from the authorized dealer so you could bring it to the DENR office for verification and inspection for issuance of a Certificate of Registration.

156 9. Kagawad Angelito Ero: Is there an authorized dealer here?
157 Forester Augreth: There is no authorized dealer within the Province of Occidental
158 Mindoro, however, we could guide you to the nearest authorized store at Oriental and
159 Manila.

161 10. Kag. Roger A. Balombong: The helper who did not actually cut the tree using the
162 chainsaw, can he also be arrested?
163 Atty: Yes, he can be arrested because he participated in committing the illegal act.

165 11. Kag. Roger A. Balombong: How about the person who asks for the cutting of the trees,
166 can he be involved?
167 Atty: Yes, he can. And a witness will be needed.

172 communities and BLGUs as their counterpart in the protection of the environment and natural
173 resources:

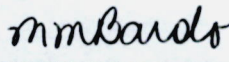
- 174 a.) Thru the MENRO the Barangay will construct an MRF where the recyclable materials
175 will be placed that will serves as their alternative source of income.
176 b.) The forest communities will protect and plant more trees along their source of water.
177 c.) The forest communities had volunteered to disseminate the information that they have
178 learned to their co-communities to protect their natural forest for their future
179 generations.
180 d.) The other agencies give their intent in protecting the environment and natural
181 resources.

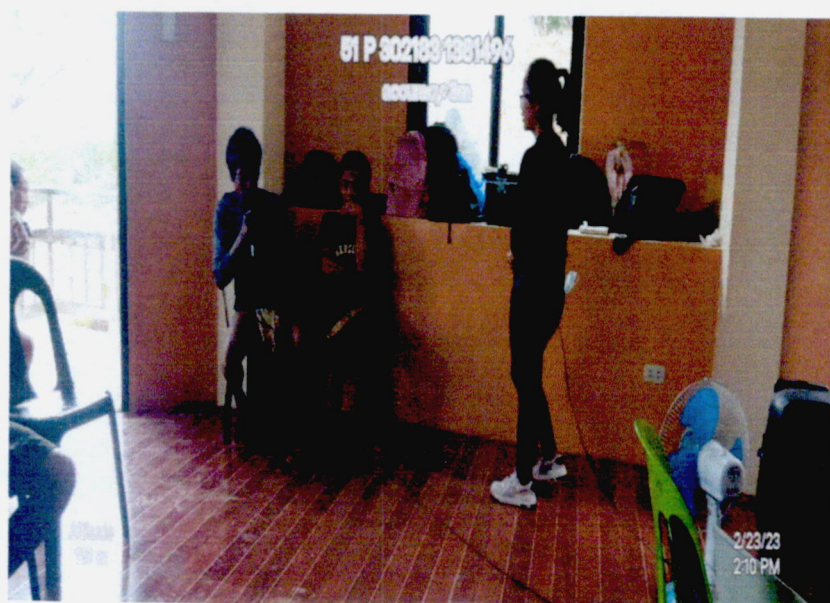
