



NARRATIVE REPORT

Department of Environment and Natural Resource (DENR) is the primary agency responsible for the protection of the Countries Environment and Natural Resources. Law enforcement and other forest protection activity is given to Enforcement and Monitoring Section (EMS) of DENR-CENR Offices.

On January 21, 2023, while conducting biodiversity monitoring and foot patrolling using SMART Lawin application at Sitio Mamara, Barangay Tubili, Paluan, Occidental Mindoro, the team suddenly found a suspected undocumented lumbers hidden in the bushes. Team leader Forest Ranger (FR) Jolly O. Mancilla marked it as a treat and immediately called the attention of the Quick Response Team (QRT) to address the said matter.

QRT headed by Forest Ranger Noel V. Salgado went to the location reported by FR Mancilla. the team then hauled the reported lumbers using the Office truck and brought to Forest Product Monitoring Station of DENR-CENRO Sablayan located at Sitio Yapang, Barangay Batongbuhay, Sablayan, Occidental Mindoro for safekeeping, additional documentation and subject for appropriate legal action.

Before leaving the area, the team left a notice stating that, whoever owns the above mentioned lumber, please proceed to the nearest DENR Office to present any document that will prove the legality of the subject.
