On March 27, 2023, our office, DENR CENRO Roxas Oriental Mindoro, received a Show Cause Memorandum from your good office dated Dec. 09, 2022, regarding the unauthorized furnishing of a copy of a Memorandum in violation of DENR DAO No. 2016-29 to which I was directed to submit a written explanation.

I, Reynaldo D. Pudiquet, do not deny that I was the one who gave Mr. Nelson Eustaquio a copy of a Memorandum dated May 19, 2021, regarding my findings on his administrative case pending the decision of the Regional Office. I did it because Mr. Eustaquio kept on asking and bothering me about the status of his administrative case. He repeatedly went to my office and kept on calling me regarding his case. I got annoyed and eventually gave him a copy of my findings as the Hearing Officer in the administrative adjudication proceedings of his case.

I explained to him that such findings are merely recommendatory in nature and not yet final and binding pending the decision of the Regional Office. Mr. Eustaquio said that he understood and he will be the one to ask the Regional Office regarding the status of his case. He requested his sister, Lucela Tagudin, to follow up on the status of his case in the Regional Office as she is a resident of Manila.

I neither had the idea nor did least expect that Mr. Eustaquio will use the said Memorandum as a ground for the dismissal of his criminal case in court. I have no intention to pre-empt the resolution of his criminal case.

With that then, I humbly apologize and implore your pardon and understanding as I admit that I got careless with handing him a copy of such a Memorandum. I was not able to foresee the consequences of such action.
