Hoping and praying that this request be granted.

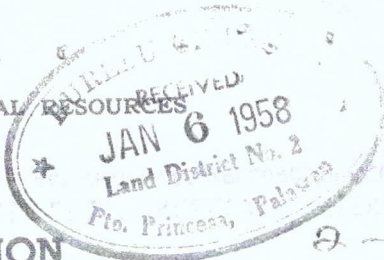

1. I hereby make application to enter the following described tract of land for homestead, as provided in Chapter IV of Commonwealth Act No. 141, as amended, to wit:

centares; said tract being as nearly as practicable rectangular in shape and not more than 1,000 meters in  
length, as indicated on page 2 hereof.

2. I certify that I have carefully cut a trail around the boundaries of the land applied for, placed prominent posts or signs at the corners, examined the same and found that it contains no indications of settlement or occupation, and to the best of my knowledge, information and belief, it contains no valuable deposits of guaro, coal or salts and is more valuable for agricultural than for forest purposes.

3. My name is CLARITA SOCRATES; my age is 23 years;  
the place of my birth is Dumaran, Palawan; I am a citizen of the Philippines  
by birth, naturalization, treaty; my post-office address is Buenavista, Pto. Princesa, Palawan;  
I am (married, single, widow, widower) and the name of my (wife, husband) is single  
and a native of \_\_\_\_\_; I am the head of a family and the following are my near relatives;

4. I am not the owner of more than 24 hectares of land in the Philippines and have not had the benefit of any gratuitous allotments of more than 24 hectares of land since the acquisition of the Philippines by the United States nor have I made any other homestead entry. The full extent of my ownership and present interest in lands in the Philippines is as follows: \_\_\_\_\_  
I have no land at all.

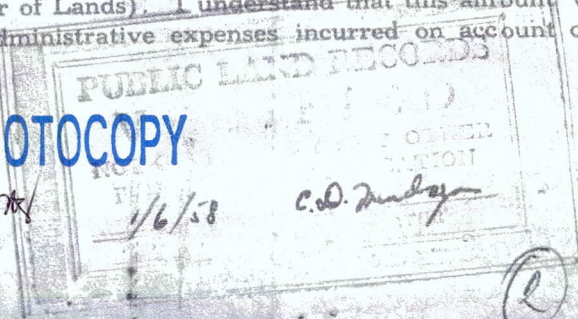
5. This application is made for land as homestead for my exclusive personal use and benefit, for the purpose of actual settlement, occupation, residence, and cultivation, and not, either directly or indirectly, for the use or benefit of any other person, persons, corporation or association of persons.

6. I will agree to conform to future delimitation, classification, survey or resurvey of the land herein applied for, and I shall before patent is issued to me accept such portion or portions assigned to me by the Director of Lands as a result of such new delimitation, classification, survey or resurvey. I understand also that this future rearrangement may add a new portion to and/or take a part of the tract originally applied for by me.

7. That I agree that a strip of forty meters wide starting from the bank on each side of any river or streams that may be found on the land I applied for, shall be demarcated and preserved as permanent timberland to the planted exclusive to trees of known economic value, and that I shall not make any clearing thereon or utilize the same for ordinary farming purposes even after patent shall have been issued to me or a contract of lease shall have been executed in my favor.

8. I understand that this application conveys no right to clear the land until this application is approved. Furthermore, I recognize that the land covered by my homestead application is of the public domain and any and all rights I may have in respect thereto by virtue of continuous occupation and cultivation, are hereby relinquished to the Government.

9. To show my good faith in filing this application and my honest intention to comply with all the requirements of the law relating to the entering and granting of Homestead, I am herewith enclosing the amount of FIVE PESOS (P5.00) as entry fee (in cash, by certified check, post office money order payable to the Director of Lands). I understand that this amount will be forfeited to the Government to defray part of the administrative expenses incurred on account of my application in case the same is rejected or cancelled.
