This is in compliance with the memorandum dated March 14, 2023 of Assistant Regional Director Donna Mayor-Gordove, CESO IV on the above subject in relation to the recommendations in the report of the IEC Team of the Technical Working Group.

Please be informed that this Office had already coordinated with the designated Environmental Monitoring Officer (EnMO) of the EMB Ms. Rio Reyes pertaining to the observations of the team. Accordingly, Ms. Reyes' reports on clean and unclean areas were submitted to EMB Regional Office with recommendation and the latter will send a letter to MLGU of El Nido noting the observations with corresponding recommendations. It was also mentioned in the report that there is a representative from the Municipal Environment and Natural Resources Office (MENRO) of El Nido, Palawan during the monitoring.

On the maintenance of MRFs, it is included in the activities under CY 2023 of GEM El Nido Master to urge the LGU to pass an ordinance for budget allocation on the MRFs maintenance and conduct training of waste characterization particularly for hard to reach areas. Moreover, to regularly monitor the compliance of LGU on RA 9003 or the Ecological Solid Waste Management Act of 2000, the EMB should deputize/designate an additional EnMOs as part of the implementation of unified command.

According to EMB PEMU during the GEM assessment held on March 1-3, 2023 at PAMO Conference Room of ENMRPA, the sanitary landfill/dumpsite of LGU located at Barangay Villa Libertad, El Nido already met its capacity, hence the LGU is encourage to establish a residual containment area. The LGU has already identified a site for the establishment of sanitary landfill which will be inspected by the EMB and MGB on its suitability. The identified site is located at Barangay New Ibajay, El Nido, Palawan.

This Office through the PAMO-ENTPRPA will coordinate with MENRO of El Nido about the supposed landfill which is likely a dumpsite and validate the concern of Barangay Chairman of Buena Suerte that their segregation at BLGU doesn't serve the purpose upon dumping at the destination site. Also, a regular collection of wastes stocks at Barangay MRFs will be coordinated.
