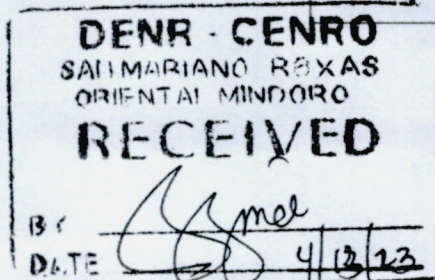

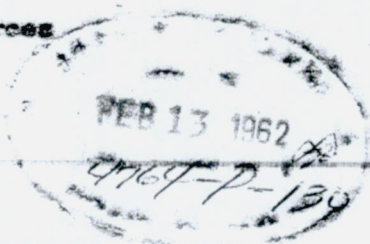

DECISION

In a verified protest dated December 31, 1959, Vicente Pinatulas claims preferential rights over the parcel of land covered by the Homestead Application No. 75844 (E-66388) of Juan de Juan (deceased) and located in San Juan, Borneo, Oriental Mindoro. In the said protest, claimant Pinatulas alleges that Catalina Abellio, wife of the deceased applicant has sold to him (Vicente Pinatulas) the parcel of land for which he is claiming preferential right.

At the investigation of this case, the herein claimant sought to show by his own testimony and the testimony of his witnesses that Catalina Abellio, wife of the deceased applicant has sold to him, under separate documents (Exhibits A and B), the tract of land covered by the Homestead Application No. 75844 (E-66388); that he took possession of 5 hectares of the land in 1937 and 4 hectares in 1938; that he made clearings on the land which were planted to rice, coconuts and bananas; that in 1934 he converted the land in dispute into an irrigated land; that his tenants who are Catalina Abellio and her children used to give him the corresponding share of the produce of the land.

On her part, respondent Catalina Abellio attempted to rebut the evidence adduced by the claimant by stating in her sworn testimony that the signatures appearing in the two documents (Exhibits A and B) are not her signatures; that after the death of her husband, she and her children continued the possession and cultivation of the land covered by the application of the deceased applicant; that they are occupying the premises in their own rights and not as tenants of the herein claimant; and that she has never given claimant Pinatulas any share of the produce of the land in controversy.

From the foregoing recital of facts, it is obvious that claimant Pinatulas bases his alleged right to the land in dispute upon the strength of documents, Exhibit A and B. While respondent Abellio repudiated the genuineness of these documents by denying her supposed signatures appearing thereon, claimant Pinatulas never presented any convincing and effective proof to show that the said documents were not fraudulently executed. Granting that the said documents were properly and legally executed, yet the same cannot be made as a source for any right emanating from the right of the original applicant. It has not been shown in the records of this case that there was a prior approval from the land department when the transfer was made. Section 20 of the Public Land Law, reads in part, as follows: "Every transfer made without the previous approval of the Secretary of Agriculture and Natural Resources shall be null and void." Furthermore, a scrutiny of the records reveals that the other heirs of the deceased applicant have not sanctioned the transactions made between claimant Pinatulas and Catalina Abellio.

Said transactions which are supposed to be a transfer of rights from Catalina Abello to Vicente Binstulac are null and void. Section 185 of the Public Land Law, provides:

Sec. 185. If at any time the applicant or grantee shall die before the issuance of the patent or the final grant of the land, or during the life of the lease, or while the applicant or grantee still has obligations pending towards the Government, in accordance with this Act, he shall be succeeded in his rights and obligations with respect to the land applied for or granted or leased under this Act by his heirs in law, who shall be entitled to have issued to them the patent or final concession if they show that they have complied with the requirements thereof, and who shall be subrogated in all his rights and obligations for the purposes of this Act."

From this legal provision, it is evident that only the heirs of the applicant can alienate or in any way encumber the land applied for. Whatever transaction, therefore, has been made between Vicente Binstulac and Catalina Abello becomes void and inoperative.

No where in the records of this case has it been shown that Catalina Abello has acquired an absolute right to the land in question which could effectively be transmitted to Vicente Binstulac. It follows, therefore, that such cession, assignment or transfer of rights made by Catalina Abello, even if true, becomes ineffective and cannot confer any right upon claimant Binstulac. "The vendor of a real estate cannot transmit to the purchaser other rights than those he possesses therein, nor can the purchaser on his part acquire other rights than such as were transmitted to him by the vendor", says our Supreme Court. In the law of nature, a stream cannot rise higher than its source.

The contention of the herein claimant that he had been in actual occupation of the land subject of this controversy and that Catalina Abello and her children are his tenants finds no support in the records of this case. In spite of the denial of Catalina Abello that she and her children are the tenants of claimant Binstulac, Binstulac never controverted such denial by presenting, in support of his contention, a tenancy contract duly executed between him on one part and Catalina Abello and her children on the other part.

The representative of this Office who conducted the on-site inspection of the premises in question reported that he could not find traces that the herein claimant has ever occupied the land; that he found Catalina Abello and her children in the actual possession and cultivation of the land in dispute; that houses belonging to the heirs of the deceased applicant were constructed thereon; and that the whole area in controversy was already converted into a plain rice land by the respondent and her children. Aside from exercising acts of dominion over the land, respondent Catalina Abello, in order to show good faith in retaining possession of the premises, declared the same for taxation purposes and paid the corresponding taxes thereon.

THE HONORABLE JUSTICE OF THE SUPREME COURT, the undersigned holds and so decides that the instant claim of Vicente Binstulac should be, and hereby it is, dismissed for lack of merit.
