Hereunder is a brief discussion of our accomplishment based on the five (5) significant performance indicators: area contracted, seedlings produced, area planted, area maintained and protected, and financial performances.

NGP Targets vs Area Contracted

As of December 2022, the region through its implementing PENROs and CENROs had completed 5376 hectares or 100% of the 5376 hectares target area. Meanwhile, a total of 728 families have been engaged under the MIMAROPA Region, 10 were contracted for FY 2022 Implementation, 713 for second year plantation establishment and 5 for third year plantation establishment.

Respecfully submitted the report of the Regional Performance Evaluation and Assessment Team in compliance to Regional Special Order (RSO) No. 215, dated July 20, 2022.

The NGP Regional Performance Evaluation and Assessment Teams were able to validate partners engaged in CYs 2018 and 2019 partners within the following jurisdiction of PENRO Occidental Mindoro and Palawan.

PENRO Occidental Mindoro with a total contracted area of 3,660 hectares covering the jurisdictions of CENRO San Jose and Sablayan and 695.28 hectares for PENRO Palawan covering the jurisdictions of CENRO Roxas, Puerto Princesa City, Taytay, Brooke's Point and Coron.

The assessment results, five (5) NGP partners in Occidental Mindoro with a total area of 290 hectares and eight (8) NGP partners with a total area of 179 hectares in the Province of Palawan passed the 85% percent survival rate, as shown in the table below.

Respectfully forwarded is the Completed Staff Work (CSW) on the Socialized Industrial Forest Management Agreement (SIFMA) No. RIV-14-001-00 issued to MR. BENITO R. ALBRANDO located at So. Bulaksina, Brgy. Dampulan, Torrijos, Marinduque.

RATIONALE/BACKGROUNDER:

Pursuant to Executive Order No. 1921 dated June 10, 1987, the DENR is empowered to exercise supervision and control over the forestlands of the Philippines. Whereas, Section 57 of PD 7052, as amended, authorizes the special use of forestlands for beneficial purposes which do not impair the forest resources therein. Moreover, DAO 24-19963 stated that it is the policy of the DENR to ensure the equitable access and sharing of rights to natural resources development and utilization by providing opportunities to the people to participate actively in forest plantation development. In line with this policy, the DENR shall provide security of tenure to the participants through the issuance of a Socialized Industrial Forest Management Agreement (SIFMA). Whereas, Section 44 of PD 705 provides the visitorial power/authority to conduct an ocular inspection and examine records/documents relating to the operation of a holder of the license agreement to determine compliance with the terms and conditions thereof. Hence, the PENRO Marinduque - Monitoring and Enforcement Team in coordination with Regional Office -Enforcement Division personnel had conducted Performance Evaluation on the SIFMA granted by the DENR to Mr. Benito R. Albrando at So. Bulaksina, Brgy. Dampulan, Torrijos, Marinduque.

RESULT OF PERFORMANCE EVALUATION ACTIVITY:

Result of the joint performance evaluation activity conducted by PENRO Marinduque - Monitoring and Enforcement Team and Regional Office - Enforcement Division personnel disclosed grave violations committed by the SIFMA holder, to wit:

- Failed to introduce improvements such as planting of forest trees and non-timber species, fruit trees, and agricultural crops for food production;
- Failed to submit the annual accomplishment reports to the DENR;
- Failed to pay the annual rental dues and interests since the issuance of the agreement on January 21, 2000; and
- Abandonment of the SIFMA area

APPLICABLE LAWS AND ISSUANCES:

- 1. PD 705 Revised Forestry Code of the Philippines
- DAO 1996-24 Rules and Regulations Governing the Socialized Industrial Forest Management Program
- 3. DAO 2004-30 Revised Rules and Regulations Governing the Socialized Industrial Forest Management Program
- 4. DAO 2020-09 Guidelines on the Management of Cancelled or Terminated, Expiring, and Expired Tenurial Instruments
- 5. DAO 2022-10 Revised DENR Manual of Authorities on Technical Matters

ACTIONS TAKEN:

- In October 13, 2021, a Notice addressed to Mr. Benito R. Albrando signed by then Regional Executive Director Maria Lourdes G. Ferrer, CESO III informing him that the agreement is already subject for cancellation/revocation pursuant to Section 16 of DAO 2004-30;
- In the progress report submitted by PENRO Marinduque dated May 30, 2022, said
 Office recommended for the cancellation of SIFMA awarded to Mr. Albrando for
 failure to comply with the terms and conditions as stipulated in the agreement;
- 3. In December 13, 2022, a Show-Cause Order signed by the Regional Executive Director Lormelyn E. Claudio, *CESO IV* was issued against Mr. Albrando with the following instructions, to wit:
 - a. Submit written explanation under oath why the lease contract shall not be cancelled for non-compliance with the terms and conditions set forth;
 - b. Submit the required annual report/s; and
 - c. Pay the annual rental fee for the use of the land since the issuance of the agreement

To date, none of the same were complied by Mr. Benito Albrando; and

4. As part of due diligence to locate his whereabouts, the team tried to contact him thru his social media account, but to no avail⁴.

RECOMMENDATIONS:

Records show that the Show-Cause Order issued by this Office already exercised a prescriptive period for the compliance of Mr. Albrando in observance of due process.

However, as of this writing, he cannot be located and failed to communicate despite the said notices.

Section 16 of DAO 2004-30 clearly stated the grounds for suspension and/or cancellation of SIFMA which are also patently indicated under the clauses of the approved agreement (SIFMA contract) were violated evidently by the holder.

After a careful review of the documents submitted and actions taken, this Office concurred with the recommendation of PENRO Marinduque for the CANCELLATION of the SIFMA contract awarded to Mr. Benito R. Albrando.

Moreover, we shall adhere to the provisions of DAO 2022-10 (Revised DENR Manual of Authorities on Technical Matters) which states that the cancellation of licenses which includes SIFMAs is within the limits of the authority of the Secretary. Thus, in case of non – compliance with Show-Cause Order, the same may be recommended for cancellation and endorsed to your Office for drafting of referral to the Secretary.

Enclosed is the case folder of the SIFMA contract awarded to Mr. Benito R. Albrando for your reference.
