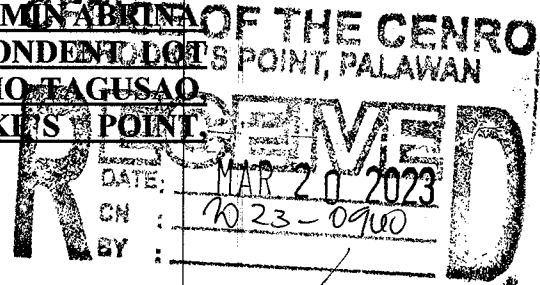


In connection with the above subject covered by Document Referral No. 2023-0960, I have the honor to submit herewith my report of service of notice, to wit:

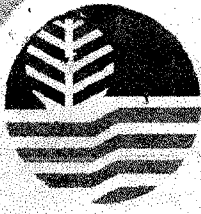

RESOLUTION

For resolution is the *Motion for Reconsideration* filed by the Protestant, thru counsel, from the Order dated May 13, 2003 issued by then Regional Executive Director Jovito B. Layugan, Jr., *CESO IV*, the dispositive portion of which is hereunder quoted:


"WHEREFORE, premises considered, the instant protest is hereby, as it is, ordered **DISMISSED** for lack of merit. Consequently, OCT No. F-4113(sic) pursuant to Free Patent No. (IV-A-10)0240 issued in favor of the Heirs of Fermin Abrina is hereby **AFFIRMED**."

Perusal of the Motion shows that the issues raised therein do not make out a new matter sufficiently persuasive to induce modification of judgment. In the case of *Philippine Coconut Producers Federation, Inc. (COCOFED) et. al. vs. Republic of the Philippines*¹, the Supreme Court held that "the instant motion is but a mere reiteration or rehash of the arguments that have already been previously pleaded, discussed and resolved by this Court xxx. And considering that the motion's arguments are unsubstantial to warrant a reconsideration or at least a modification, this Court finds no reason to modify or let alone reverse the challenged Decision." As such, we find no ground or cogent reason to disturb and/or modify the Order dated May 13, 2003.

WHEREFORE, premises considered, the Motion for Reconsideration filed by the Heirs of Jalele Darma, represented by Bebeja K. Darma, thru their counsel, is hereby **DENIED** for lack of merit.
