RESULT OF ADMINISTRATIVE ADJUDICATION PROCEEDINGS OVER THE APPREHENDED FIVE (5) PIECES OF AMUGIS LUMBER WITH A TOTAL VOLUME OF 117.48 BOARD FEET IN BARANGAY ANTIPOLO, GASAN,

MARINDUQUE

Respectfully endorsed is the Memorandum report dated March 17, 2023, regarding the above-mentioned subject.

Please be informed that this proceeding stemmed from an incident on January 26, 2023 at around 10:38 in the morning wherein personnel of the Protected Area Management Office, received an information from Mr. Fidelino M. Rey (Chief, Tanod) of Barangay Antipolo, Gasan, Marinduque regarding the utilization of one (1) Amugis tree at the said barangay.

Accordingly, coordination was immediately made by the team and found out that no permit was issued in the said area. Therefore, the team coordinated with Sangguniang Barangay of Antipolo regarding the apprehension of said forest products.

The said apprehended forest product, which consist of five (5) pieces Amugis lumber with a total volume of 117.48 board feet, were temporarily placed under the custody of Brgy. Captain Arsenio G. Saez of Barangay Antipolo for safekeeping, pending conduct of Administrative Confiscation Proceedings in accordance with DAO 97-32.

Likewise, pursuant to Section 8 item no. 3 of DAO 97-32, the Hearing Officer prepared notices of apprehension dated January 27, February 03 and 10, 2023 and posted by the Forest Officers at conspicuous places such as Barangay Hall of Antipolo, Gasan, Marinduque and apprehension site. This is to inform the general public of such apprehension and to determine the owner of said forest products. The posting of Notice of Hearing started on January 27, 2023 and ended up on February 16, 2023, but nobody claimed ownership of said forest products, hence, it was considered as "abandoned forest product".

Relative thereto, the Apprehending Officer issued a certification to prove that the notices of apprehension were posted at different places as part of due process, but nobody claimed ownership over the same.

In view of the above findings, we recommend the issuance of **Confiscation Order** on the said undocumented forest products in favor of the government.

RESULT OF ADMINISTRATIVE CONFISCATION PROCEEDINGS OVER THE APPREHENDED FIVE (5) PIECES OF AMUGIS LUMBER WITH A TOTAL VOLUME OF 117.48

BOARD IN BARANGAY ANTIPOLO, GASAN, MARINDUQUE

Please be informed that on 26 January 2023 at around 10:48 in the morning, personnel of Protected Area Management Office (PAMO) Marinduque Wildlife Sanctuary received a mobile phone call from Fidelino M. Rey (Chief Tanod) of Barangay Antipolo, Gasan, Marinduque regarding the sawn lumber at the said area.

Coordination was made to our Office to verify any issued permit in the said area but to no avail. In relation to this, the team coordinated with Sangguniang Barangay of Antipolo, Gasan, Marinduque regarding the apprehension of abandoned undocumented forest products at the above-mentioned barangay.

Meanwhile, during the initial investigation, there was no one in the area who claimed its ownership. Upon scaling it was found to be five (5) pieces Amugis lumber with a total volume of 117.48 board feet. The said apprehended forest products were temporarily, under the custody of Brgy. Captain Arsenio G. Saez of Barangay Antipolo, Gasan, Marinduque for safekeeping, pending conduct of Administrative Confiscation Proceedings in accordance with DAO 97-32.

However, pursuant to Section 8 item no.3 of DAO 97-32, the undersigned prepared notice of apprehension dated January 27, February 03 and 10, 2023 and posted by the forest officers at conspicuous area such as Barangay Hall of Barangay Antipolo, Gasan, Marinduque and at the apprehension site. This is to inform the general public of such apprehension and to determine the legal owner of said undocumented forest products. The posting of notice of hearing was started on January 27, 2023 and ended up on February 16, 2023. Unfortunately, within the prescribed period, nobody claim ownership on such undocumented forest products, hence, the same were considered as "abandoned".

Relative thereto, the apprehending officer issued a certification to prove that the notices of apprehension were posted at different places as part of the process, but nobody claimed ownership. Further, considering the circumstances given above, it is hereby recommending for the issuance of **Confiscation Order** on the subject forest products in favor of the government and issuance of forfeiture order.
