Please be inform hat on November 17, 2022 late in the afternoon at about 7:13 PM the undersigned suddenly received a text message thru cellphone from Alcantara MLGOO and was received by Alcantara PNP station that there an alleged illegal ongoing hauling of sawn slice lumber at Brgy, Bonlao, Alcantara, Romblon. Beforehand personnel of the PNP Alcantara Station coordinated first with one of the DENR personnel Eddie G. Dulay Jr. to accompany them and the team spearheaded by PMAJ CHISI F. FADERAGAO, ACOP and night duty personnel namely PMSG Aries Minano, PSSG Anjo Mesana, PCPI Rodiefer V. Catajay, PSSG, Regan M. Kaneses, PSSG Andrew C. Faclarin to proceed in said place to ascertain the information and absolutely confirmed and able to recovered abandoned lumber and identified sliced NARRA with different dimension. Just because of evening and limited time they decided and planned to secure and safeguard the abandoned slice narra lumber at once by the participation of barangay Bonlao Pulis Tanod.

Of even date (November 18, 2022) suddenly the undersigned received call thru cellphone from the OIC, Chief Monitoring Enforcement Section For-II James M. Mendoza gave instruction to proceed at Brgy. Bonlao, Alcanara, Romblon to ascertain the veracity of said information transpired. So he undersigned immediately proceeded in the alleged illegal activity. For in depth interrogation and investigation in the area no body once ever claims behind the subject item. Based for the violation having committed by the perpetrators for the existing forestry laws rules and regulation they violated sec 77 of PD 705 as amended by RA 7161. After thorough investigation/verification by the undersigned they scaled and inventoried the seven (7) pcs slice Narra lumber with different dimension such 4"x19"x5', 3"x19"x6', 3"x25"x8', 3"x34"x8' with total volume of Three Hundred sixty Four Point one (364.1) bdft. With estimated value of Php 65,538.00.

Again they decided to come to office of the MLGOO Alcantara together with the undersigned DENR personnel and with the PNP Alcantara to communicate regarding the transfer

and hauling of the confiscated item and it was given favor and granted to lend their truck to transfer the item custody from the Punong Barangay Hon. Antonino Agascon to the lead agency DENR custody for proper safekeeping purposes and further pending investigation for the disposition thereof.

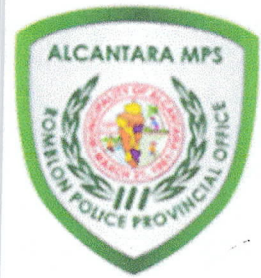

1. What: Accomplishment Report re: Abandoned Lumber.
2. Where: Barangay Bonlao, Alcantara, Romblon
3. When: November 17, 2022 at about 7:13 PM.
4. Who: The perpetrator/s is yet to be identified.

5. How: On November 17, 2022 at about 7:13 PM, a text message from Alcantara MLGOO was received by this station informing this office that there is ongoing hauling of sawn Narra lumber at Barangay Bonlao, Alcantara, Romblon. Thereafter, personnel of this station coordinated to the personnel of DENR in the person of Eddie Dulay (lead agency) and a team led by PMAJ CHISI F FADERAGAO, ACOP with three (3) other personnel proceeded to the mentioned place and able to discovered said lumber abandoned beside the barangay road. Upon verification of the said abandoned lumber, it was disclosed that Narra lumbers were sawn in different dimension with a number of three (3) pieces of 3"x34"x103", two (2) pieces 3"x25"x104" and two (2) pieces 3"x20"x65" with a total volume of 4, 576 board feet were discovered in plain view by the operating elements however the perpetrators were no longer to be found at the scene. The team exerted effort to identify the loggers and locate the owner of said lumbers but to no avail. The aforesaid lumbers were then subsequently confiscated, properly documented by Eddie Dulay and were temporarily turned over to Barangay Captain Antonino Agascon for temporary safe keeping and will be hauled to DENR Office at Odiongan, Romblon for proper disposition. The estimated market value is Six hundred eighty six thousand pesos (Php 686,400.00). The place of incident was for further investigation by the office of DENR for plotting and mapping. Attached herewith are the copies of action photos taken during the conduct of illegal logging operation for reference.
