Respectfully submitting is the Management Effectiveness Assessment (MEA) Report of CALSANAG Watershed Forest Reserve located at Tablas Island, Romblon, C.Y. 2023.

Based on the Management Effectiveness Tracking Tool (METT) results, this protected area obtained the following rating by element, to wit: a.) Context 33.33%; b.) Planning 98.99%; c.) Input 59.47%; d.) Process 73.00%; e.) Outcomes 80.30%; and f.) Output 33.33%.

Accordingly, the Final METT Score (Total METT Rating + Additional Points Rating) is 88.51%. It means that the management effectiveness status is Excellent.



1. Description of the Protected Area

1.1. Area Description and Location

The Tablas Island is used to be a well-wooded island at the turn of the nineteenth century according to Worcester and Bourns (1898) as cited by Ong, Afuong, and Rusell-Ambal (2002) which signifies the origin of its name and is one of the sources of prime wood. But in the early 60s to 70s the area was logged by concession occupying more than one half of the area which now is identified as the priority area for conservation and research for arthropods, classified extremely high for amphibians and reptiles, extremely high for marine, very high for birds and very high biological level of importance for terrestrial and inland water areas (Ong, P.S., et. al. 2002).

The CALSANAG Watershed Forest Reserve (CWFR), the largest intact watershed in the island is considered as one of the priority conservation areas of various critical ecosystems, and is the habitat and home to globally threatened species. It has about 37 species, 7 orders, and 21 families of birds identified across ecosystems (MODECERA, 2017). One distinctive taxon is the Tablas Drongo (Dicrurus menagei), a species endemic to the Tablas Island and is considered endangered due to its very small population. It is declared as key species in the area by PAMB, and found nowhere else in the world but listed in IUCN as endangered (BirdLife International, 2016). It was believed to be extinct but the last sightings in 1998 proved that the species is extinct, albeit rare (Allen, 2006). Another notable species is the Colasisi or Philippine Hanging Parrot (Loriculus philippinensis), an endemic to the Philippines which has occasionally been found intoxicated on palm wine or tuba. About 8 species of fruit and insect bats were recorded including the Little Golden-Manteled Flying Fox (Pteropus pumilus). This is considered as near threatened and decreasing in population due to hunting and habitat destruction. In terms of spider diversity, a total of 597 spider individuals belonging to 14 genera under the families of Araneidae, Clubionidae, Oxyopidae, Linyphiidae, Thomisidae, Nephilidae, Pisauridae, Sparassidae, Tetragnathidae, Theridiidae, and Theraphosidae were recorded and 52% of these spiders are found in the grassland ecosystem (Fadri and Barrion, 2017). The most abundant family is Araneidae including the following: Argiope catenulate, Argiope luzona, Argiope aemula, Neoscona theisi, Neoscona molemensis, Neoscona punctigera, Gasteracantha diasdemia, Poltys illepidus, Poltys n. sp. and Poltys elevatus. A Theraphosid, Orphnaecus sp. was also common in the CALSANAG Watershed Forest Reserve. The Orphnaecus sp. and Poltys sp. are newly discovered species in the Philippines identified in CALSANAG Watershed while *Thomisus sp.* and the *Thomisus* guangxicus the new records in the Philippines (Fadri and Barrion, 2017). The insect diversity of CALSANAG also composed of 11 insect orders mostly dominated by Lepidoptera, Phasmatodea, Hymenoptera, and Orthoptera (MODECERA, 2017). The CALSANAG area is still the habitat of Philippine Palm Civet (Musang) through the presence of stool/feces in the area (DENR-BMS, 2017).

In terms of flora, a total of 109 species belonging to 50 families and 83 genera of

vascular plants were identified. Thirty (30) taxa or 27% of total species identified belonging to 20 families and 26 genera have distributions that are confined only to the Philippine Archipelago. A total of 15 species or 14% of total species are listed under the DAO 2007-1 and IUCN (2016) red lists of threatened species (Motin et.al., 2016).

The CWFR is composed of three adjoining municipalities, namely: Calatrava, San Andres, and San Agustin. It is located at the Northern part of Tablas Island approximately between 120° 35' North latitude and 122° 04' East longitude. It is one of the 240 protected areas in the Philippines managed by the Department of Environment and Natural Resources (DENR) as mandated by the National Integrated Protected Areas System (NIPAS) Act of 1992. Previously proposed as CALSANAG Protected Landscape, it was established as CALSANAG WFR under Proclamation No. 2186, signed on April 29, 1982, during the Marcos administration. CALSANAG used to cover 2,670 ha public domain identified in the BFD Map LC-660 certified on May 27, 1927. However, result of recent survey conducted by Regional Assessment Delineation Team (RADT) in May 8-22, 2014, the covered area was reduced to 2,614.28 hectares, as indicated in Figure 1.

1.2. Human Populations and Boundaries

Nine barangays are located near the reserve area, which include Linawan, Marigondon Norte, and Agpudlos in San Andres; Balogo, San Roque, and Pagsangahan in Calatrava; and Doňa Juana, Dubduban and Binongaan in San Agustin.

A result of the Survey and Registration of Protected Area Occupants (SRPAO) made in 2017 using Socio-Economic Assessment and Monitoring System (SEAMS) revealed 185 household heads are PA occupants, however, only 83 are considered Tenured Migrants based on proof of occupancy submitted and validated from three municipalities. These household heads are largely composed of males with 89.19% compared to 10.81% females. The number of tenured migrants' household heads per municipalities is as follows: San Agustin has the highest number of tenured migrants accumulating 34 household heads (40.96%), followed by Calatrava with 30 household heads (36.14%), and San Andres with 19 household heads (22.89%). Meanwhile, no groups of Indigenous People are found occupying in the protected area.

2. Methodology (Methods used, date of assessment, respondents)

2.1. Collection of relevant documents

The following documents sourced from DENR PENRO Romblon were used for the assessment and evaluation process:

- 1. Calatrava, San Andres, San Agustin Watershed Forest Reserve: Management Effectiveness and Capacity Assessment Report in 2013, 2016 & 2020
- 2. General Management Plan (GMP)
- 3. CALSANAG Map shapefile

2.2. Facilitated METT Scoring

A total of 11 respondents participated on the assessment and evaluation of CALSANAG WFR using the Management Effectiveness Tracking Tool (METT) as the survey instrument with one representative-respondent from each of the concerned LGUs covered by the watershed and one DENR representative-respondent. The Punong Barangay or member of the Barangay Council as well as Municipal Officials represented the LGUs while the PASu represented the DENR.

To complete the full METT implementation, the respondents were invited during the conduct of 1st Quarter CALSANAG Watershed Forest Reserve- Protected Area Management Board held at Linawan Barangay Covered Court, Barangay Linawan. San Andres, Romblon on February 10, 2023. After the meeting of the Board, the respondents in the conduct of METT convened for the assessment, completing all the METT including all questions on the datasheets and narrative sections related to the multiple choice questions with initial deliberation of the results and discussion of the next steps. This was facilitated by Technical Working Committee of the PAMB. Through the facilitated scoring system of the METT, the emerging threats and issues in the management of the CALSANAG WFR were identified. Each member individually scored the METT after all the management indicators were fully explained by the facilitators and understood by the respondents. It was important that the scoring and basis of scoring were clear and commonly understood by the respondents.

Respondents of the assessment comprised of the following:

- (1) Municipal Mayor Marieta F. Babera of Calatrava, Romblon;
- (2) Punong Barangay Ernie T. Enquillo of Marigondon Norte, San Andres, Romblon;
- (3) Punong Barangay Resty G. Gabaldon of Linawan, San Andres, Romblon;
- (4) Municipal Mayor Arsenio G. Gadon of San Andres, Romblon;
- (5) Protected Area Superintendent Raymund G. Inocencio;
- (6) Punong Barangay Sulpicio G. Machado of Binongaan, San Agustin;
- (7) Municipal Mayor Esteban S.F. Madrona, Jr. of San Agustin, Romblon;
- (8) Punong Barangay Josefina M. Manalon of Doña Juana, San Agustin, Romblon:
- (9) Punong Barangay Rolando M. Selosa, Sr. of Agpudlos, San Andres, Romblon;
- (10) Punong Barangay Juliet M. Sixon of Balogo, Calatrava, Romblon; and
- (11) Punong Barangay Redeemer D. Solano of Dubduban, San Agustin, Romblon.

3. Results and Analysis

3.1. Significance/Values/Key Features

Approximately, 36% (967.89 ha) of the original total land area (2670 ha) of the CALSANAG WFR is forest, while 28% (755 ha) and 25% (680.36) is grassland and coconut, respectively. Shrubs, pasture, and cultivated land covered the remaining area of the reserve.

From the inventory result of previous research projects on CWFR,¹ the forest area is dominated by locally known dipterocarp species such as "Lauan", "Tanguile", "Apitong", "Bagtikan", "Yakal", and "Manggachapui" and has an estimated mean total of 315 stems/ha representing 98 species found naturally thriving in the area belonging to 47 families. This indicates that the present forest structure and composition in the CALSANAG watershed may be at its early build-up phase towards a more complex structure and composition (i.e. climax phase). The high number of small-diameter classes indicates the abundance of young trees typical of natural forests and is a manifestation of ecosystem resilience.²

Moreover, based on the report on Resource Valuation Project in the CWFR (2020)³, the CWFR is critical in the provision of various ecosystem services and functions that help the economies of the surrounding agricultural and coastal communities directly and indirectly. These services include the supply of food, timber, and non-timber forest products;

regulation of carbon sequestration, water supply and quality, and soil protection; and essential underlying functions such as oxygen production.

3.2. Threats/Stressors

The CALSANAG WFR currently faces issues and threats. Error! Reference source not found. presents the result of threat values based on the METT responses of the respondents. The highest possible answer in threat values is 11 representing a total of 11 respondents. However, values can also have a total of less than 11 since some respondents' answers were "no data" or not-applicable" which were not accounted.

Overall, the respondents perceived that all threats presented are facing a low level of threat. Of the identified low level threats, the biological resource use and harm within a protected area has the highest mean value of 0.85, followed by agriculture and aquaculture within a protected area at 0.67, geological event at 0.61, specific cultural and social threats at 0.53 and residential and commercial development within protected area at 0.33. This means that low level threats are primarily due to some human disturbance like timber and non-timber poaching activities as observed within Barangays Balogo and San Roque, Calatrava and Barangay Mari-Norte, San Andres. This includes gathering of poles for household use and extraction of "Balew" leaves for weaving Bayong baskets. Thus, human extractive activities within terrestrial ecosystems shall be fully monitored and controlled by the management.

3.3. Management Effectiveness

Context. The context refers to the legal status of CALSANAG WFR which was established as such by virtue of Presidential Proclamation No. 2186 on 29 April 1982. All of the assessors except for two, gave a rating of zero and two which put the total rating for context at 33.33% (Error! Reference source not found.). The exception gave a rating of zero, a rating for not having the CWFR gazetted despite the discussions presented during the assessment. Currently, this protected area is under review of the National NIPAS Review Committee. Based on the result of Protected Area Suitability Assessment (PASA), the CALSANAG Watershed Forest Reserve is for inclusion to the National Integrated Protected Areas System (NIPAS) under the category of Protected Landscape.

Although all of the identified threats were perceived as low impact threats, the threat of a growing population, new road openings to and from the area, and the continuously increasing demand for lumber and firewood and other forest products exposes the protected area to threats made by human. Thus, the proclamation of the CALSANAG Watershed Forest Reserve as a protected landscape under NIPAS is critical in a small island community.

Planning. The planning element evaluates the established vision, goals, objectives and strategies to conserve values and reduce threats. Specifically, this area of management being assessed is comprised of CALSANAG WFR regulations, objectives, design, management plan, work and financial plan (WFP), and land and water planning. This element of evaluation for CWFR has the highest level of consolidated rating at 98.99% (Table 3) with maximum scores attained on issues concerning the protected area objectives, protected area design and Regular Work Plan (Annual WFP).

Currently, it has the General Management Plan (GMP) applicable until 2022 submitted but is yet to be approved so funding for its planned activities are dependent on the regular budget of the DENR-PENRO and respective LGUs for protection and conservation activities. Environmental profile of the CWFR was undertaken through the biodiversity assessment on the flora and fauna resources conducted by Romblon State University using its internally and externally generated funds.

Inputs. The input element assesses the resourcing of the DENR and the resourcing of the protected area. This specifically considers how resources of staff, money and equipment are allocated to work towards the objectives. It considers law enforcement staff, availability of information, staff number and training, current budget, security of budget, equipment and fees in the management and protection of CWFR. The assessors gave an overall quality of input rating of 59.47% (Table 4) with the lowest score (lower middle ratings to zero) on the issues of: 1) fees, as there are no entry fees or fines collected, and 2) staff members, as there are inadequate for critical management activities. Only 3 regular staff assigned in the protected area.

On the issues of law enforcement, security of budget, staff training, current budget, most of the assessors gave the upper middle rating while the resource inventory obtained the highest rating. There are related researches on biodiversity conducted over the last 5 years however, information dissemination was limited. Furthermore, in terms of law enforcement, the LGUs PA Rangers and DENR PENRO -Monitoring and Enforcement Section personnel augmented the limited number of protected area staffs but there are some deficiencies in staff training, enforcement plan, budget and equipment, including the systematic monitoring and reporting.

Process. The process element evaluates the suitability of management processes and how the management board implement management actions according to its processes. The consolidated percentage rating for the process element of management is 73.00% (Good; Table 5), which reflects how the PAMB was re-established from its dormancy to undertake

its mandate, a big improvement from 2013 METT results of 15% (Poor), 29.74% (Fair) in 2016 and 72% (Good) in 2020. This is supported by local communities' direct contribution to some relevant decisions, adequate budget management, delineation and knowledge of boundary, active undertaking of resource management, conduct of research and development of program of management-oriented survey, and conduct of monitoring and evaluation of management activities and against performance. However, some issues that need to be addressed further are those that concern on commercial tourism operators and state and commercial neighbours.

Outputs. The outputs element assesses the implementation of management programs and actions as well as delivery of products and services. All of the assessors gave a rating of 1.0 which put the total rating for output at 33.33% (Table 6). Despite inadequacy of visitor facilities, there was one newly-maintained ecotourism shed in Balogo, Calatrava that served as reception shed to cater local tourists in this area.

Outcomes. The outcomes element assesses the outcomes and the extent to which they achieved objectives. Majority of the assessors gave a rating of 1.0 which put the total rating for outcomes at 80.30% (Table 7). Since this protected area is a watershed, it provides abundant water to the Municipalities of Calatrava, San Andres and San Agustin, Romblon for household, agricultural, industrial and institutional use. Then, some pristine natural pools and waterfalls found in the areas that attract tourists both local and foreign. In addition, the academe and other agencies continuously conduct biodiversity research/program and

information dissemination that in the end help to address biodiversity threats and maintain key biodiversity, ecological and cultural values in the protected area.








Mgt. Effectiveness: 17.83% (Poor)
