REQUEST FOR PARTICIPANTS: TRAINING

WORKSHOP ON CARRYING CAPACITY FOR SUSTAINABLE TOURISM IN PROTECTED AREAS UNDER THE NIPAS TO BE HELD FROM JULY 25 TO

AUGUST 4, 2023 AT A VENUE TO BE DETERMINED

The Biodiversity Management Bureau (BMB), in partnership with the Ecosystems Research and Development Bureau (ERDB), is pleased to inform you that a Training Workshop on Carrying Capacity for Sustainable Tourism in Protected Areas will be held from July 25 to August 4, 2023 (including travel time) at a venue to be determined.

The primary objective of the workshop is to provide key personnel from protected areas and regional offices with the necessary knowledge and skills to conduct carrying capacity assessments in ecotourism sites. By the end of the workshop, participants are expected to have gained a comprehensive understanding of the protocol, concepts, and importance of setting carrying capacity in ecotourism destinations within protected areas, as well as the skills to compute the different components of carrying capacity assessment.

The workshop will be conducted in two phases. Phase I will focus on the introduction and computation of different components of carrying capacity assessment, while Phase II will cover the in-depth computation of limiting factors, preparation of survey tools for social, physical, and biodiversity, and data encoding, tabulation, and analysis using Microsoft Excel or Statistical Package for Social Sciences (SPSS) software. The workshop will include both lectures and a field practicum in tourist destinations within a prot2ected area.

The Workshop will be attended by one (1) representative each from the DENR Conservation and Development Division-PA Management and Biodiversity Conservation Section (PAMBCS), as well as representatives from the attached list of protected areas with targets on formulation/updating of the Ecotourism Management Plan and Carrying Capacity Study. Please note that the list of PAs was prioritized based on the 2023 targets derived from the latest



Regional Work and Financial Plan. Should there be changes in the targets, staff from CDD and PAMO may update the list.

In this regard, may we request the list of participants from your respective Regions and protected areas using the attached matrix and online link: https://bit.ly/CarCapWorkshop on or before May 5, 2023. Representatives from the PAMO should preferably be the focal person for ecotourism development. This list will serve as the basis for the DENR - Special Order and will also confirm the participants for the said Workshop.
