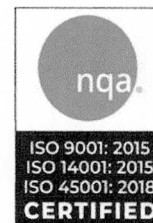

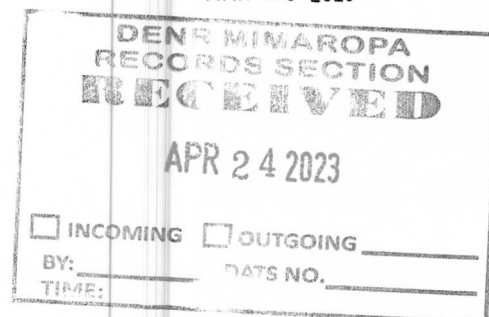

Tampipi and Franck Albert Jules Dewaste, represented by Michelle Miriam Gajetos, Paintiffs, versus Spouses Rogel A. Gabat and Jocelyn Gabat, and all persons claiming rights and interest under the, Defendants, for Accion Reivindicatoria and Damages with Prayer for the Issuance of a Writ of Preliminary Mandatory Injunction before the Regional Trial Court (RTC) Branch 40, Calapan City.

Please be informed that our office has no employee record of any of the alleged DENR-NCR personnel mentioned in the letter, specifically Salvador Glori and Engr. Gigi Tugno.

Further, per verification of records, our office did not receive any communication from Mr. Dewaste, his representative, Ms. Michelle Miriam Gajetos, or his legal counsel, Atty. Ronaldo O. Macalanda, in relation to above-mentioned Civil Case. Also, considering that the subject property is located in Calapan City, Oriental Mindoro, it would have been unfitting for our office to be involved in the conduct of survey because the area is outside our jurisdiction.
