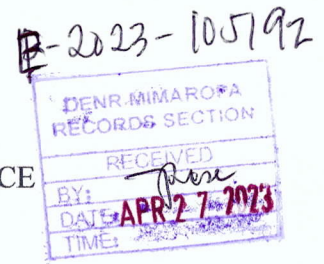

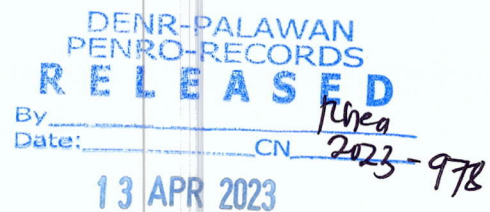



Last 31 March 2023, this office has received a memorandum about the above mentioned subject wherein a certain Mr. Jose Danico has sent a compliant letter via DENR 8888 hotline dated 13 March 2023. Relative thereto, an instruction to conduct an investigation on the alleged spreading of laterite ores in the area having adverse effects on agricultural and fish products, and to coordinate with the company to apply for Foreshore Lease Agreement (FLA) or Miscellaneous Lease Agreement (MLA) for the constructed pier was given to this office.

In response therewith, the following are the findings from the conducted investigation.

1. Last March 31, 2023, CENRO Brooke's Point personnel proceeded to the pier area of INC to conduct a visual inspection on the possible signs of laterite spreading that may affect the agricultural and fish products in the area as mentioned in the complaint.

Upon reaching the pier site, the team observed that the beach sands and other sediments near the pier lack any apparent reddish/brownish coloration typically observed upon the spread of nickel-iron laterite material. Further inspection of the creek that drains the haul road and stockpile area of INC also revealed that visually there are no discernible laterite materials along the channel and its surroundings. The same is also true on the Mambalot River which drains the INC minesite. No visually discernible laterite deposits were observed on the bank and along the river channel (*see photo documentation*).

2. Water sampling results taken last January 2023 for the 4th Quarter MMT of INC also showed that the levels of arsenic, cadmium, manganese, and lead are significantly below the standard level of safety accepted by DENR (*see Annex A*).


3. According to the monthly rainfall data from PAGASA date 1-29 March 2023(*see Annex B*), Southern Palawan has experienced 0-25mm of rainfall which was categorized as having way below normal average rainfall (<40% less rain compared to normal). Furthermore, the transport of laterite ore towards the stockpile area near the pier has been stopped since the start of the ongoing public protest against the operation of INC last 18 February 2023(*see Annex C*). Hence, the spread laterite materials during this particular period is highly unlikely.
4. Last 24 March 2022, INC has applied for Miscellaneous Lease Agreement (MLA) for the use of the foreshore land where their causeway/port will be constructed. A provisional permit (*see Annex D*) has been granted by the Regional Executive Director (RED) valid for the period of 01 June 2022 to 01 June 2023. Additionally, their application for permit to construct has been approved by the Philippine Ports Authority – Port Management Office, Palawan last 05 April 2022 (*see Annex E*).

Similarly, a special land use permit has been granted by the RED on 17 March 2022, which will expire on 18 March 2025, for the public forestland situated in Brgy. Maasin, Brooke's Point, Palawan. This privilege was granted to Ipilan Nickel Corporation for their use as Access Road (*see Annex F*).

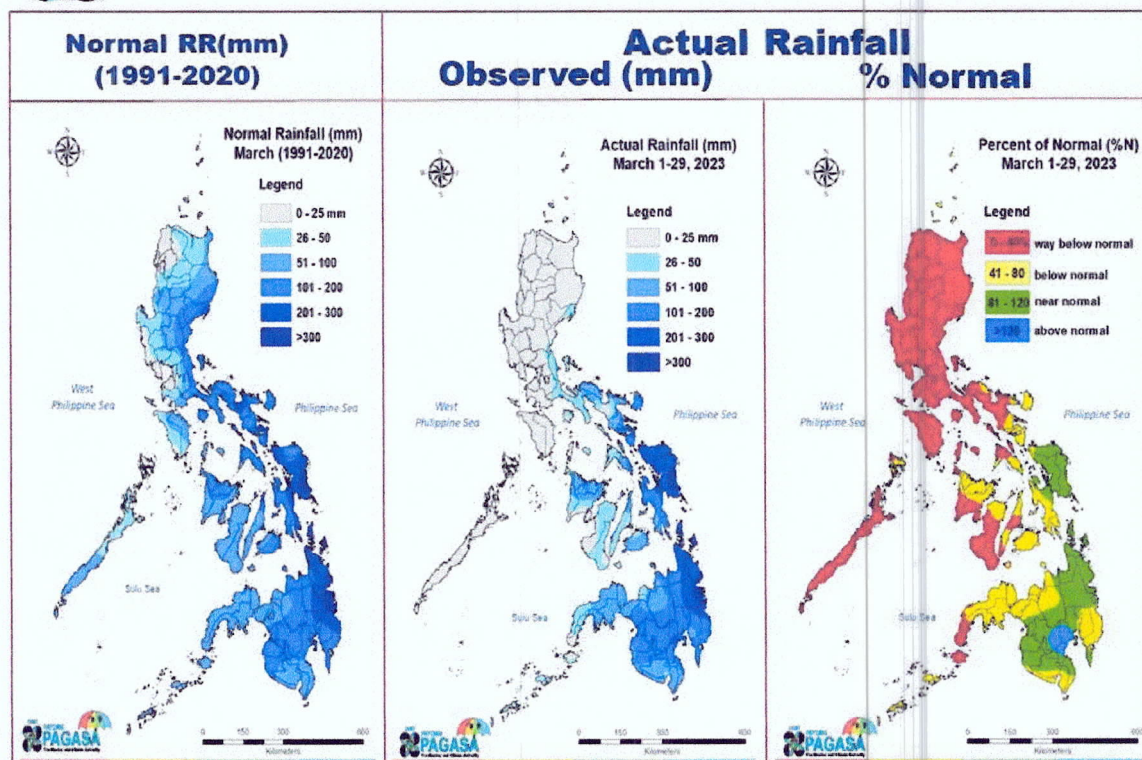
