Respectfully submitting is the First Quarter CY-2023 Report on the Technical Assistance to LGUs on coastal and marine related concerns under WFP 2023 - Coastal and Marine Ecosystems Rehabilitation Sub-Program.

This Office have provided technical assistance to the Island Municipalities of Verde Island Passage Concepcion, Corcuera and Banton, Romblon to activate their emergency response plan and conduct regular monitoring activities in the affected areas to determine the extent of the oil spill and to assess any potential damage to the environment and community. However, the municipality of Concepcion responded that as of March 21, 2023 there was no sighting within the municipal waters of Concepcion from the submerged M/T Princess Empress. We will keep you updated once we receive an update from Banton and Corcuera and submit report immediately if the oil spill reaches our area of responsibility.

In reference to your letter dated 7 March 2023, regarding the oil spill incident that involved the submerged MT Princess Empress, we have been closely monitoring the municipal waters of Concepcion since the incident happened. The undersigned wishes to inform you that as of 21 March 2023, there was no sighting within the municipal waters of Concepcion of the oil spill from the sunken M/T Princess Empress in the vicinity waters of Naujan, Oriental Mindoro, on 28 February 2023.

This is contained in a Post-Activity Report report by CG PO1 Leonel M. Dalit, Sub-Station Commander, Coast Guard Sub-Station Concepcion, who, together with MDRRMC officer-in-charge John Bob Ferranco, PNP Municipal Police Station, and Municipal Agriculture Office, conducted a Joint Seaborne Patrol (JSP) and inspection along the municipal waters on 21 March 2023.

Likewise, I have standing orders for the continuous monitoring for a possible oil spill reaching the island's municipal waters, including coordinating with the nine (9) barangay captains to work with their respective Barangay Fishery and Aquatic Resource Management Councils (B/FARMCs) in patrolling their maritime waters to watch out for an oil spill trace.

Relative to the above, fishermen of the Municipality continue with their regular fishing activities, with excess fish catch being exported to Oriental Mindoro under the strict implementation of the Auxiliary Invoice requirement of national laws and appropriate local ordinances.
