WHEREAS, the proposed port zone delineation of the Port of Puerto Galera will comprise an approximate area of 555,355.87 square meters or 55.54 hectares in which port facilities will be developed to intensify economic activities in the area and support the interconnectivity of MIMAROPA island provinces and municipalities as well as with the other regions;

WHEREAS, the port facility is expected to further boost the tourism industry and serve as vital link for the efficient movement of people, goods, and services in the Municipality of Puerto Galera and to the whole Mindoro Island;

WHEREAS, the proposed port zone delineation of the Port of Puerto Galera in Barangay Balatero, Municipality of Puerto Galera was favorably endorsed by the Sangguniang Barangay of Balatero (Resolution No. 2014-04), Sangguniang Bayan of Puerto Galera (Resolution No 002-2015), and Provincial development Council of Oriental Mindoro (Resolution No. 03, Series of 2015);
