

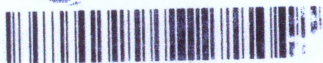
In this regard, may we respectfully request the assistance of your technical staff to look into the program glitch that we are experiencing with our LAMS system.

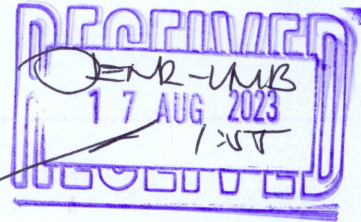
