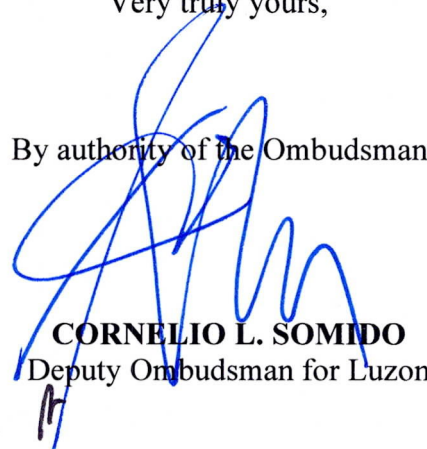

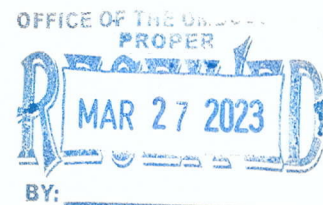

Salamat sa inyong pang-unawa sa mga bagay na ito.



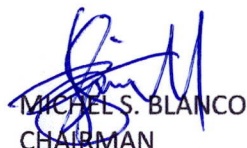
