1. Examine available records/documents on the subject CBFM-PO;

2. Coordinate with the party concerned in the provision of pertinent documents on the subject CBFM-PO:

3. Assess CBFM-People's Organizations (POs) in their role as tenure holder using the Second Party obligations stated in the CBFMA and in other related

4. Determine the extent of the area developed by the PO projected in maps

using GIS with geotagged photos; and

5. Identify remedial measures/areas for improvement for the catch-up plan of CBFMA-POs and submit report to the Regional Executive Director containing categorical recommendation as to renewal, re-evaluation or non-renewal of the subject CBFMA for review and endorsement to the Undersecretary for Field Operationsor the designed approving authority for final decision and action.

Travelling expenses and per diems incurred during the conduct of evaluation shall charged against Conservation and Development Division (CDD) funds, or their respective office funds, subject to existing accounting and auditing rules and regulations.

This Order takes effect immediately and shall remain in force unless revoked in writing.
