PROJECTION OF THE PRIORITY FIFTY (50) APPROVED CADTS/CALTS INDORSED BY THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES (NCIP) TO THE LAND REGISTRATION AUTHORITY (LRA) FOR REGISTRATION / CERTIFICATE OF NO OVERLAP (CNO).

Respectfully submitting our Narrative Report on the projection of all pending patents and resource use instruments falling within CADTs/CALTs of NCIP as per JAO 2012-02 with corresponding shape files, list of pending patents, CBFMA, mining tenements and NGP sites, to wit:

1. CADT/CALT No. R04-RIZ-0709-129

We found One hundred forty-three (143) cadastral lots; twenty (20) mining tenements; Ten (10) NGP sites from CY 2011 to 2020 Projects, and Three (3) protected area sites overlapping within the boundary.

2. CADT/CALT No. R04-QUE-0709-131

We found Four Hundred fifty (450) Unapplied lots; One Hundred forty (140) Patented lots: one (1) CBFMA site; twenty (20) mining tenement; Nine (9) NGP sites from CY 2011 to 2019 Projects overlapping within the boundary.

3. CADT/CALT No. R04-ABO-0709-128

We found Five Hundred ninety (590) cadastral lots; Four (4) CBFMA sites; Five (5) mining tenements; One (1) NGP site from CY 2011 to 2019 Projects overlap within the boundary.
