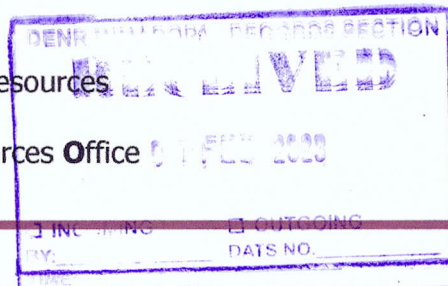

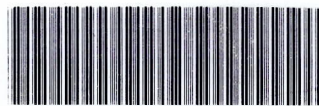
SUBJECT : **REQUEST FOR TRANSFER OF OFFICE OF FORESTER I LEHEN


