


This pertains to the submitted Community Resource Management Framework (CRMF) plan of Tumagabok Small Farmers Association (TSFA) formerly Tumagabok Upland Farmers Multipurpose Cooperative (TUFMC) located in Barangay // Tumagabok, Boac, Marinduque.

Based on review of the submitted documents, hereunder are our observations and recommendations:

1. Provide Community Map of all existing developments and projects in hectares reflected on the legend (NGP, CARP, etc.). Indicate other projects inside the CBFM area and CSC areas, if any and reflect the area in hectares on the map legend;
2. Revise/update Tables 4, 5 and 6 – please start from 2023 to 2028 which is the remaining years of the CBFMA;
3. In Community and PO Profile Item 5.2 (Existing development) - the total area on Production Forest/Livelihood is 13.4 hectares and there is still 4.0 hectares production forest which is more than the total area of CBFMA which is 10 hectares – verify and reconcile the data;
4. Provide the corresponding area in hectares of all proposed development and projects on the legend of the Vision Map;
5. Attach copy of PO Resolution on Benefit Sharing of the PO on the harvesting and marketing of its products;
6. Revise the Affirmation sheet and Approval sheet of Five Year Work Plan (using the latest format);
7. Attach copy of PO Registration from a government agency;
8. The title of the CRMF should be Tumagabok Small Farmers Association (TSFA) formerly Tumagabok Farmers Multipurpose Cooperative (TUFMC).

Relative thereto, please rectify and submit the above documents/data prior to the affirmation of the said CRMF.
