

That this DEED OF DONATION, made and entered into by and between:

INTERNATIONAL FUND FOR ANIMAL WELFARE (IFAW), a global non-profit organization, engage in rescuing, rehabilitation, releasing, and restoring, protecting animals and their natural habitats, with principal office address at 290 Summer Street, Yarmouth Port, Massachusetts, USA, represented by its Program Manager, **LOIS LELANCHON**, hereinafter referred to as the **DONOR**;

PALAWAN WILDLIFE RESCUE AND CONSERVATION CENTER (PWRCC) a wildlife rescue center under the management and supervision of Department of Environment and Natural Resources Region IV-B (DENR IV-B) located at Brgy. WITNESSETH:


That the DONOR is the lawful owner of the equipment procured for the Care for Confiscated Wildlife (CCW) training which shall consists of the following:


That the DONOR further states, for the same purpose as expressed in the next preceding paragraph, that this donation is not made with the object of defrauding his creditors;


