Forwarded is the Memorandum from CENRO-Taytay, Palawan along with Memorandum of PASu Mildred A. Suza of El Nido-Taytay Manage Resource Protected Area (ENTMRPA) and the inspection report of the Team relative to the above subject.

Recent compliance monitoring disclosed that no additional structures or improvements were made within the area. However, the proponent was found non-compliant on the self-demolition of structures within the 40-meter legal easement as agreed during the meeting last December 8, 2022 at Bayview Hotel.

Further, we would also like to reiterate our previous Memorandum dated January 12, 2023 requesting for legal advice and clarification whether or not there is still a need to issue summons or conduct preliminary conference with the parties considering that the Regional Office have already conducted technical conference and with a written agreement among those who attended.

Respectfully forwarded is the memorandum dated November 25, 2022 from Forest Rangers Herson Y. Caliao and Jonathan A. Arzaga pertaining to the above-mentioned subject with attachments.

The team recorded a total of twenty-three (23) structures built by the Lihim resort without Protected Area Management Board (PAMB) endorsement. The subject area is currently under dispute between the Ten Knots Philippines Inc. (TKPI) and Mr. Israel Gomez and Mrs. Baberlyn Gomez per submitted Complete Staff Work (CSW) dated August 31, 2022.

This office concurs with the recommendations of the enforcement officers particularly on the issuance of Status Quo Order and conduct of Technical conference.

The technical conference and meeting regarding the issue was conducted in Manila last December 8, 2022 which was attended by both parties (TKPI and Lihim Resort together with Mr.Israel Gomez). Agreements were made in the presence of RED Lormelyn Claudio, CENRO Conrad Corpuz and PENRO Alan Valle as well as the DENR Regional office officials and staff. Copy of such agreement is not yet disseminated to concerned officers for information.

This pertains to the letter dated November 18, 2022 from Jordan L. Calderon, Security manager of Ten Knot Philippines Inc. regarding the continuous installation/construction of structures and fencing of salvaged zone by Lihim Resort located at Sabang, Cadlao Island, Barangay Buena Suerte, El Nido, Palawan.

On November 23, 2022, the undersigned along with Park Rangers Manuelito F. Jongay, Jerremeil Tacob and Ryan Cacacha and Forest Protection Officers Mark Christian Yntas and Jovan P. Villanueva conducted inspection and verification on the said area.

The team found out the following:

- 1. That the said area being occupied by Lihim Resorts at Cadlao Island has existing conflict (overlapping claims) with Ten Knots Philippines Inc. (TKPI) as the said area has existing approved FLAgT issued to TKPI and at the same time registered before the Registry of Deeds dated April 27, 2015.
- 2. On November 22, 2021, the said area is identified within ENTMRPA falling within Multiple Use Zone based on report from ENMTRPA PAMO personnel.
- 3. On August 31, 2022, a Complete Staff Work (CSW) was submitted by Assistant PASu Jenuel P. Casel re Conflicting Claims between TKPI, Mr. and Mrs. Israel Gomez at Sabang Beach, Cadlao Island, Barangay Buena Suerte, El Nido, Palawan. The report recommends status quo in the area and the conduct of technical conference.
- 4. On September 8, 2022, an Order of Investigation was issued by Regional Executive Director Lormelyn E. Claudio in reference to the letter request of TKPI dated July 28, 2022 re Cancellation of Katibayan ng Orihinal na Titulo (KOT) Blg. 2015000225 in the name of Baberly D. Gomez, KOT Blg. 2015000222 and KOT Blg. 2015000223 both in the name of Noel Tampe, all located at Cadlao Island, Barangay Buena Suerte, El Nido, Palawan.
- 5. Based on the said Order of Investigation, records show that on December 27, 2005, the DENR awarded TKPI FLAgT No. DENR-IV-MIMAROPA-12302030-0010 for Bathing Establishment covering 3.206 hectares of forest land located at Cadlao Island, Barangay Buena Suerte, El Nido, Palawan for the period of twenty-five (25) years and to expire on December 30, 2030.

- 6. Based on the said Order of Investigation, records also further show that KOT Blg. 2015000225 in the name of Baberly D. Gomez and KOT Blg. 2015000222 and KOT Blg. 2015000223 both issued in the name of Noel Tampe were duly registered before the Registry of Deeds by virtue of Kaloob na Patente Blg. 045312-15-35600, 045312-15-35601 and 045312-15-35602, respectively, on April 27, 2015.
- 7. The said area is now being occupied and developed by Lihim Resorts despite the verbal instructions from the Protected Area Management Office to cease any development as the area has existing conflicts and overlapping claims with the other party.
- 8. An inventory conducted by the undersigned shows the current structures in the area as of November 23, 2022:
  - a. Ten (10) units cottage within easement;
  - b. Two (2) mini bars (movable) within easement;
  - c. One (1) reception area, stone and concrete based;
  - d. One (1) storage room;
  - e. Two (2) villas, concrete based;
  - f. One (1) staff house, light materials;
  - g. Three (3) ongoing movable platforms, light materials;
  - h. Three (3) villas (on-going).
- 9. On one (1) area where another villa will be constructed, the team also documented ongoing under-brushing activity.

With the above results, the team recommends as follows:

- 1. Conduct continuous monitoring in the area;
- 2. Status Qou in the area is recommended until the dispute is settled by both parties;
- 3. Conduct technical conference with the claimants and concerned government offices to conclude a unified decision and resolution over the issue.


In reference with the DENR Order of Investigation dtd September 8, 2022 issued by the Regional Executive Director, DENR, MIMAROPA, MS. LORMELYN E. CLAUDIO, CESO IV, she directed PENRO Palawan to assign a Land Investigation Officer (LIO) to investigate on the KOT BLG. 2015000225 in the name of Baberlyn D. Gomez, KOT BLG. 2015000222 and KOT BLG. 2015000223 both in the name of Noel Tampe, all located at Cadlao Island, Barangay Buena Suerte, El Nido, Palawan, for the said KOTs are allegedly within timberland area and overlap with the TKPI's FLAgT.

However, despite the above Order of Investigation issued by the DENR MIMAROPA, the Lihim Resort located in Sabang, Cadlao Island continuously installed structures and fenced the salvage or easement zone, guarded by an armed group.


