This is in compliance with PENRO Special Order No. 010 dated February 07, 2022 relative on the creation of teams of Wildlife Traffic Monitoring Unit within the province of Marinduque for the month of January 2023 to wit;


- On January 11-17, 2023 Forest Rangers Florante G. Fandialan Jr., FR Michael Joseph A. Maranan, FR Jerahmeel L. Bronce together with Forest Protection Officers assigned within seaports and airport of Brgy. Dos, Gasan, Marinduque, Brgy. Cawit, Marinduque and Brgy. Buyabod, Sta. Cruz, Marinduque conducted regular monitoring of possible wildlife transportation. Likewise, conducted coordination within Philippine Port Authority (PPA), Philippine Coast Guard and Terminal Port Manager (TMO) within the area.
- On January 17, 2023 Forest Rangers Jonathan L. Telan and FR Rica Quennie D. Radovan together with assigned Forest Protection Officers coordinated with Philippine Port Authority (PPA) and head of security officer of Balanacan Port regarding the monitoring activity and functions of the team as Wildlife Traffic Monitoring Unit.

Please be informed that Marinduque Airport within Barangay Masiga, Gasan Marinduque were temporarily closed due to pandemic and their operations were temporarily stop.

As to wildlife and forest products/minerals, no transportation was monitored during the said period.

Further, informational materials such as flyers regarding Republic Act No. 9147 "Wildlife Conservation and Protection Act" and other DENR forestry laws, rules and regulations were also distributed as part of public awareness.

SUBJECT : **REPORT ON WILDLIFE TRAFFIC MONITORING AT THE MAIN SEAPORTS AND AIRPORT IN THE PROVINCE OF MARINDUQUE.**

In compliance with the target activities of Technical Services Division-Monitoring and Enforcement Section under Operations against Illegal Environment and Natural Resources activities, please be informed that the undersigned had conducted monitoring within the seaports located in Barangay Dos, Gasan and Barangay Cawit, Boac and airport located in Barangay Masiga, Gasan, Marinduque January 11 and 17, 2023.

Be informed further that the undersigned coordinated with the personnel of Philippine Coast Guard-Gasan Substation thru SN1 Del Rio. Moreover, the undersigned together with CG SN1 Del Rio conducted monitoring of passengers travelling to Pinamalayan, Mindoro via passenger boat for possible transport of wildlife. On the same day, the undersigned proceeded to Terminal Management Office (TMO) - Cawit, Port of Cawit at Barangay Cawit, Boac. According to the Security Guard on-duty Mr. Renante Montiano, there still no schedule of trips of passenger vessels in the port. Only cargo vessel and barge were berthed in this port to unload cements and local rice (NFA). In addition, Forest Ranger Jerahmeel L. Bronce together with the personnel of Philippine Coast Guard, conducted monitoring of passengers travelling to Cantanuan, Quezon, Maniwaya, Mompong and Polo, Island, Sta. Cruz, Marinduque. At Marinduque Airport located in Barangay Masiga, Gasan, there is still no domestic flight in said airport. During the time of wildlife traffic monitoring, no illegal transport of wildlife encountered by the monitoring team.

In view hereof, continuous monitoring within the seaports and airport is hereby recommended to prevent illegal activity. Attached herewith area geo-tagged photos of the said activity.

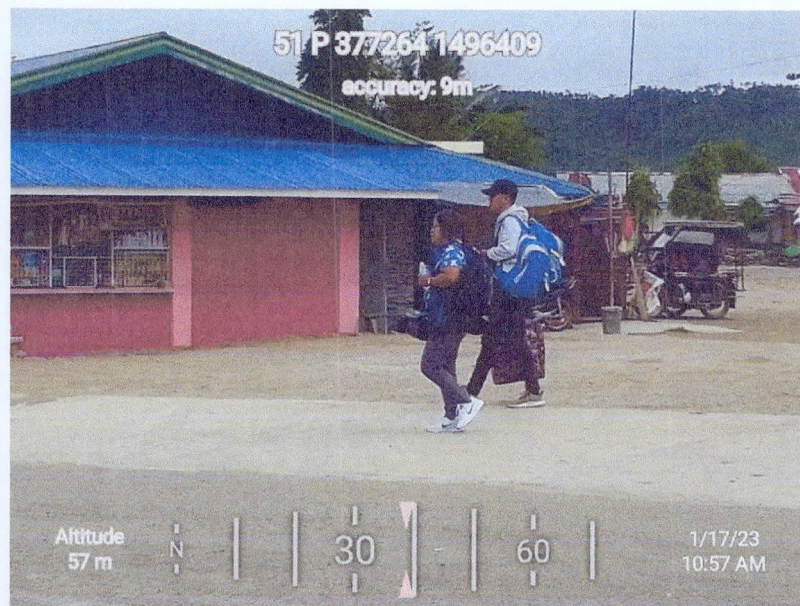

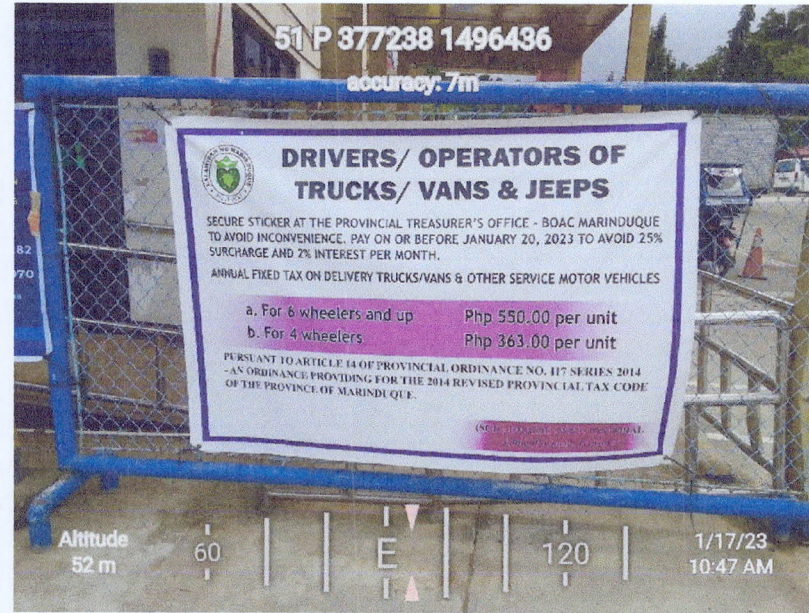
