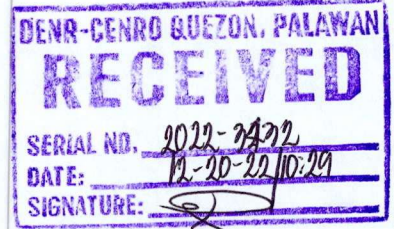

HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of remaining forest, and secure the protection and maintenance of planted trees.

The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners especially with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, reforestation of denuded forest and establishment of endemic fruits & trees, and high value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high value fruit tree plantation; and
- (6) help improve the living condition of IP's and non-IPs through the promotion of raising the indigenous tree and fruit tree seedlings.



For this month of November 2022, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- a. Last November 2022, Lionheart Farms (Philippines) Corporation (LFPC) Foot Patrol Unit continue conducting regular on-site monitoring of illegal activities inside the JVA and adjacent areas. And as of this month, there is no trace of Illegal activities such as Girdling of trees, charcoal making, illegal collection of salvage log, illegal kaingin, collection of endangered species, illegal collection of forest products, poachers of wildlife as well as Illegal loggings monitored in the vicinity and neighbors of the Lionheart areas, that's because of the presence of the DENR-CENRO Quezon, Kilusan Sagip Kalikasan (KSK) staff, Non-government Organization (NGO) and Barangay and also the Foot Patrol Unit team of the Lionheart Company. ***(Please see photos attached as ANNEX A)***
- b. Last November 2022, Lionheart Farms (Philippines) Corporation (LFPC) continued conducting Seedlings production, Care and Maintenance inside the Forest Tree Nursery. The following activities of seedling production in the nursery are polybagging, collecting of Mahogany (*Swietenia macrophylla*), pruning and transplanting of wildlings. The following activities for care and maintenance in forest tree nursery are Foliar application, Watering, Weeding, organizing of seedlings and polybags. The total seedling stocks maintained in forest tree nursery is Thirteen Thousand Five Hundred Forty Two (13,542) seedlings. ***(Please see photos attached as ANNEX B)***
- c. Last November 2022, Lionheart Farms (Philippines) Corporation (LFPC) the nursery caretaker continued collecting Mahogany (*Swietenia macrophylla*) wildlings for seedlings production and to complete the target in tree plantation. The nursery workers collected Mahogany (*Swietenia macrophylla*) wildlings with a total of Four Thousand Eight-Hundred Ninety-Six (4,896) wildlings. Those wildlings were planted directly. ***(Please see photos attached as ANNEX C)***
- d. Last November 2022, Lionheart Farms (Philippines) Corporation (LFPC) continued conducting land preparation such as strip brushing, alignment and sticking, holing and planting of wildlings. The team accomplished alignment and sticking of Four Thousand Six-Hundred Fifty (4,650) pieces of sticks. ***(Please see photos attached as ANNEX D)***




- e. Last November 2022, Lionheart Farms (Philippines) Corporation (LFPC) the planters continued conducting planting of Mahogany (Swietenia macrophylla) located at Upper Malutok, Ransang, Palawan. The total Mahogany (Swietenia macrophylla) planted this month was Six-Thousand Sixty (6,060) seedlings. ***(Please see photos attached as ANNEX E)***

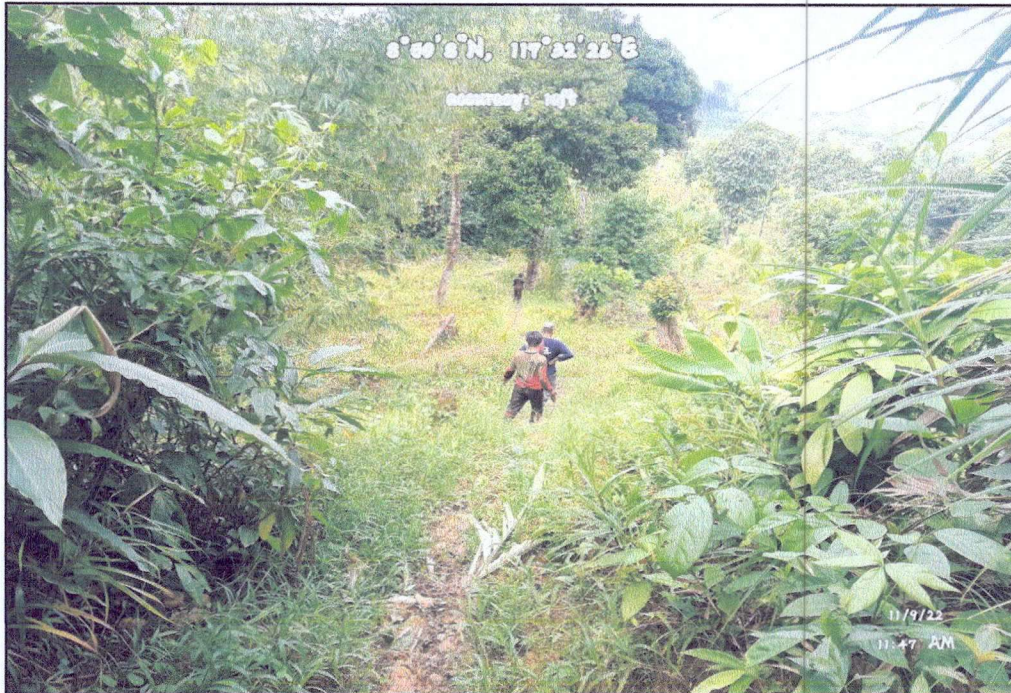

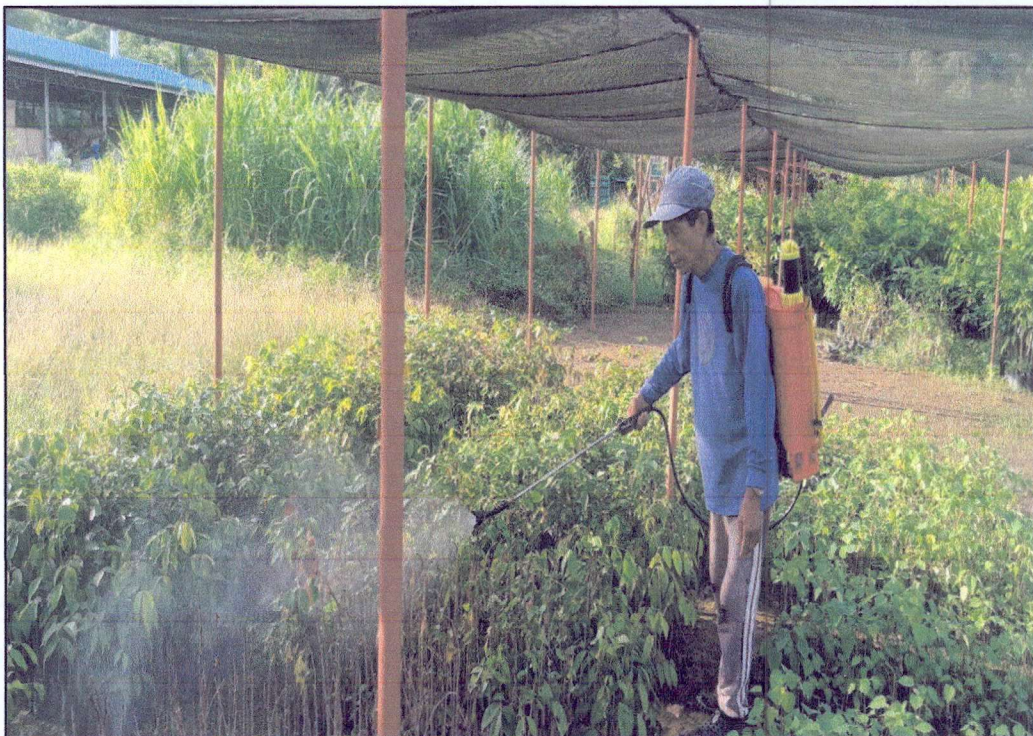

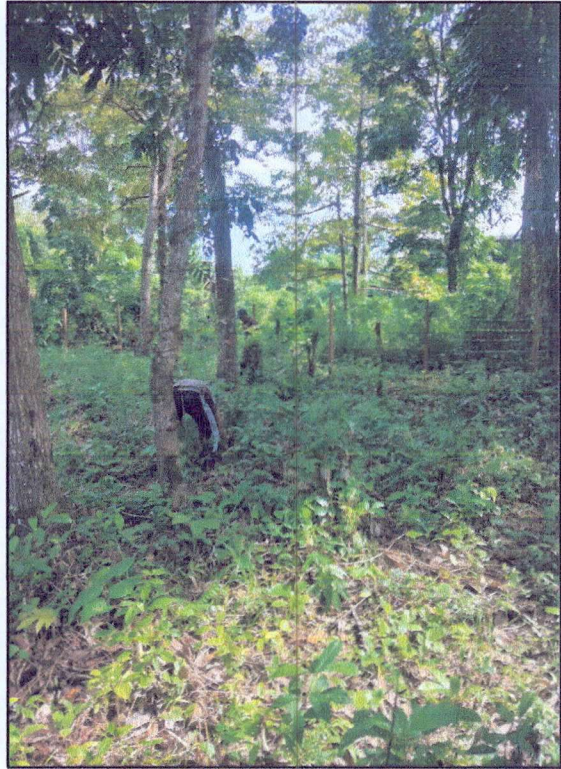

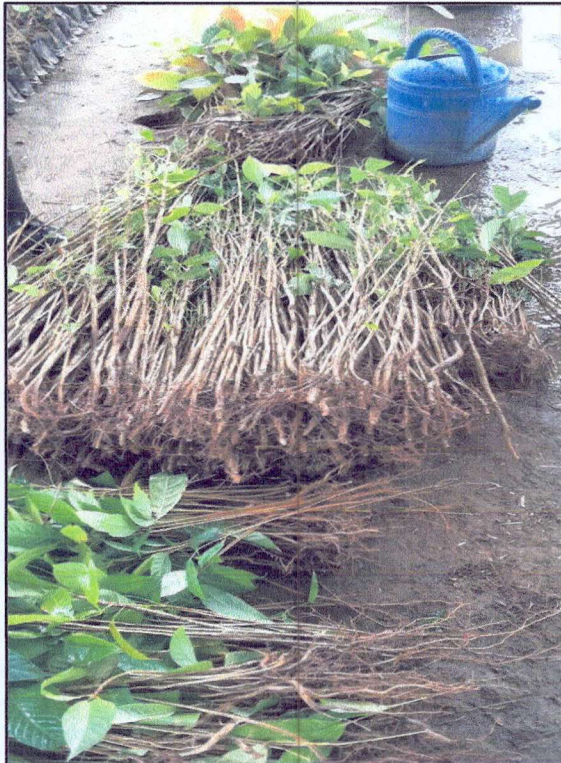
