I am submitting the investigation report conducted on the application for Survey Authority of Victoria Gapuz, et. al over Lot No. 6771-I, CSD-04-021286-D containing a total area of 19, 112 sq.m located in Bgy. Batang-Batang, Narra, Palawan.

After the conduct of the evaluation, I found out the following:

a. The subject parcel of land is within Alienable and Disposable (A&D) Land per Project No. 10-H of Land Classification Map No. 1742 approved on March 23, 1954.

### b. Other findings:

- 1. Records of this Office show that Lot No. 6771-I, CSD-04-021286-D was listed under the name of certain Ernesto Gapuz, however, the same was not covered by any public land application;
- 2. Ocular inspection/investigation conducted by LMI Vina Anaclito revealed that Victoria Gapuz and Lolita Holguin are the actual occupants of the area and intends to segregate the area based on their respective occupation;
- 3. That the area is fully cultivated as evidenced by planted full-bearing coconut trees and shanty houses thereon;
- 4. The whole area is free from claims and conflict, as vouched-safe by a certification issued by *Punong Barangay* Rudy F. Bonales on June 6, 2022.
